WHEREAS, the City Government of Alaminos, Pangasinan advertised the Invitation to Bid for the **PROPOSED SEVEN (7) UNITS SMALL FARM RESERVOIR (SFR) AT BRGY. MAAWI, CITY OF ALAMINOS, PANGASINAN** in the G-EPS, Alaminos City website and a conspicuous place at the premises of the City Hall Building continuously for 20 days;

WHEREAS, in response to the said advertisements, only one (1) bidder purchased bid documents;

WHEREAS, on January 10, 2022 only (1) bid submitted on time and opened by the City's Bids and Awards Committee;

WHEREAS, the detailed evaluation of bids conducted on July 19, 2021 resulted in the following:

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder with the Lowest Calculated Bid, **DONGPONG CONSTRUCTION**, its bid has been found to be *Responsive*.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:
