

CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 14th day on December, 2021 between CITY GOVERNMENT OF ALAMINOS, represented by City Mayor **ARTH BRYAN C. CELESTE**, with an office address at Alaminos City Hall Building (hereinafter called the "Entity") and **JONIK TRADING AND CONSTRUCTION**, represented by **NIDA CALISO** with an office address at Brgy. Bolaney, Alaminos City, Pangasinan (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **PROPOSED REHABILITATION OF OLD AND NEW BUILDING AT CITY SCHOOL DIVISION OFFICE, BRGY. POBLACION, CITY OF ALAMINOS, PANGASINAN** (hereinafter called "the Works") and the Entity has accepted the Bid for **TWO MILLION THREE HUNDRED SIXTY-NINE THOUSAND THREE HUNDRED NINETY-TWO PESOS AND 94/100 (P2,369,392.94)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this agreement, words and expressions shall have the same meanings as are respectively assigned to them Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs):
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - Bid form, including all the documents/statements contained in the Bidder's Bidding envelopes, as annexes, and all other documents submitted (e.g., Bidders response to request for clarification in the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Performance Security
 - d. Notice of Award of Contract and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice of Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **TWO MILLION THREE HUNDRED SIXTY-NINE THOUSAND THREE HUNDRED NINETY-TWO PESOS AND 94/100 (P2,369,392.94)** or such other sums as may be ascertained, **JONIK TRADING AND CONSTRUCTION** agrees to complete /finish the execute **PROPOSED REHABILITATION OF OLD**
