**INVITATION TO BID FOR THE PROCUREMENT OF VARIOUS VETERINARY SUPPLIES TO BE USED FOR DEWORMING OF SMALL AND LARGE RUMINANTS AND FOR ANTI-RABIES VACCINE OPERATIONS AT VARIOUS BRGYS. IN ALAMINOS CITY, PANGASINAN**

1. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN**, through *its Development Fund*<sup>1</sup> intends to apply the sum of ***Two Hundred Six Thousand Seven Hundred Pesos (Php 206,700.00)*** being the Approved Budget for the Contract (ABC) to payment under the contract for **PROCUREMENT OF VARIOUS VETERINARY SUPPLIES TO BE USED FOR DEWORMING OF SMALL AND LARGE RUMINANTS AND FOR ANTI-RABIES VACCINE OPERATIONS AT VARIOUS BRGYS. IN ALAMINOS CITY, PANGASINAN.**

Bids received in excess of the ABC shall be automatically rejected at bid opening.

The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** now invites bids for the **PROCUREMENT OF VARIOUS VETERINARY SUPPLIES TO BE USED FOR DEWORMING OF SMALL AND LARGE RUMINANTS AND FOR ANTI-RABIES VACCINE OPERATIONS AT VARIOUS BRGYS. IN ALAMINOS CITY, PANGASINAN.** Delivery of the Goods is required within **fifteen (15) days upon receipt of the Notice to Award.** Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.
- Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** and inspect the Bidding Documents at the address given below from **July 19 – August 13, 2012.**
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Hundred Sixteen Pesos (Php 516.00).**

Bids must be delivered to the BAC Secretariat Office, Budget Office, City Hall Building, Poblacion, Alaminos City, Pangasinan on or before **August 13, 2012 at 9:00 A.M.** at **BAC Secretariat Office, Budget Office, 2<sup>nd</sup> Floor, Alaminos City Hall Building, Alaminos City, Pangasinan**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **August 13, 2012 at 9:30AM** at **Conference Room, 2<sup>nd</sup> Floor, Alaminos City Hall Building, Alaminos City, Pangasinan**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
