**INVITATION TO BID FOR THE RENOVATION OF STAGE, COMFORT ROOM, CONCRETE BENCH
AND GATE AT BRGY. PANDAN, ALAMINOS CITY, PANGASINAN**

1. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN**, through *its Countrywide Development Fund*¹ intends to apply the sum of **Six Hundred Forty Eight Thousand One Hundred Forty Three Pesos and Sixty Four Centavos (Php 648,143.64)** being the Approved Budget for the Contract (ABC) for payment under the contract for the **RENOVATION OF STAGE, COMFORT ROOM, CONCRETE BENCH AND GATE AT BRGY. PANDAN, ALAMINOS CITY, PANGASINAN**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** now invites bids for the **RENOVATION OF STAGE, COMFORT ROOM, CONCRETE BENCH AND GATE AT BRGY. PANDAN, ALAMINOS CITY, PANGASINAN**.² Completion of the Works requires **Sixty (60) Calendar Days**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** and inspect the Bidding Documents at the address given below from **May 7 – June 1, 2012**.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **One Thousand Six Hundred Twenty Pesos (Php 1,620.00)**.

It *may also be downloaded* free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity (www.alaminoscity.gov.ph) , provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.
6. Bids must be delivered on or before **June 1, 2012 at 9:00 A.M. at Conference Room, 2nd Floor, Alaminos City Hall Building, Alaminos City, Pangasinan**. All bids must be accompanied by a bid security in any of the acceptable forms in the amount as stated in ITB Clause 18. Late bids shall not be accepted.

¹ In the case of National Government Agencies, the General Appropriations Act and/or continuing appropriations; in the case of GOCCs, GFIs, and SUCs, the Corporate Budget for the contract approved by the governing Boards; in the case of LGUs, the Budget for the contract approved by the respective *Sanggunian*. (Section 5(a), R.A. 9184)

² A brief description of the scope of Works should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

Bid opening shall be on **June 1, 2012 at 9:30AM** at **Conference Room, 2nd Floor, Alaminos City Hall Building, Alaminos City, Pangasinan**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below.

7. The winning bidder is entitled an advance payment of 15% of the contract and the remaining balance shall be paid by the City only after the issuance of Certificate of Project Completion by the City.
8. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
