**INVITATION TO BID FOR THE PROCUREMENT OF GROCERY ITEMS TO BE USED FOR THE IMPLEMENTATION OF FEEDING PROGRAM IN ALAMINOS CITY, PANGASINAN FOR THE PERIOD OF OCTOBER TO DECEMBER 2012 AND JANUARY TO MARCH 2013.**

1. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN**, through *its Trust Fund*<sup>1</sup> intends to apply the sum of ***One Million Two Hundred Eighty Two Thousand Eight Hundred Pesos (Php 1,282,800.00)*** being the Approved Budget for the Contract (ABC) to payment under the contract for the **PROCUREMENT OF GROCERY ITEMS TO BE USED FOR THE IMPLEMENTATION OF FEEDING PROGRAM IN ALAMINOS CITY, PANGASINAN FOR THE PERIOD OF OCTOBER TO DECEMBER 2012 AND JANUARY TO MARCH 2013.**

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** now invites bids for the **PROCUREMENT OF VARIOUS GROCERY ITEMS TO BE USED FOR THE IMPLEMENTATION OF FEEDING PROGRAM IN ALAMINOS CITY, PANGASINAN FOR THE PERIOD OF OCTOBER TO DECEMBER 2012 AND JANUARY TO MARCH 2013**. Delivery of the Goods is required within **fifteen (15) days upon receipt of the Notice to Award**. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.  
  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** and inspect the Bidding Documents at the address given below from **September 6 – October 1, 2012**.
5. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** will hold a Pre-Bid Conference on **September 18, 2012 at 9:00 A.M at Conference Room, 2<sup>nd</sup> Floor Alaminos City Hall Building, Alaminos City, Pangasinan**, which shall be open only to all interested parties who have purchased the Bidding Documents.
6. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **One Thousand Seven Hundred Eighty Two Pesos (Php1,782.00)**.
7. Bids must be delivered to the BAC Secretariat Office, Budget Office, City Hall Building, Poblacion, Alaminos City, Pangasinan on or before **October 1, 2012 at 9:00 A.M. at BAC Secretariat Office, Budget Office, 2<sup>nd</sup> Floor, Alaminos City Hall Building, Alaminos City, Pangasinan**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **October 1, 2012 at 9:30AM at Conference Room, 2<sup>nd</sup> Floor, Alaminos City Hall Building, Alaminos City, Pangasinan**. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

8. To be eligible prospective bidders shall be in the industry for **at least 2 years**.

Delivery schedule will be provided by the City Social Welfare Office and Development Office after the Notice of Award and the winning bidder is responsible to deliver the goods on the day it will be needed.

In order to promote livelihood to locally grown producers/farmers of the City, the winning bidder shall procure goods from the list of local producers/farmers provided by City Agriculture Office.

9. The bid security shall be in the following amount:

- The amount of **Twenty Three Thousand Seven Hundred Sixty Two Pesos and Eighty Centavos (Php 23,762.80)** or *[ 2% of ABC]*, if bid security is in cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit;
- The amount of **Fifty Nine Thousand Four Hundred Seven Pesos (Php 59,407.00)** or *[5% of ABC]* if bid security is in Surety Bond; or
- Any combination of the foregoing proportionate to the share of form with respect to total amount of security.

10. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
