**2<sup>ND</sup> INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF TWENTY THOUSAND (20,000) PIECES BAMBOO PLANTING MATERIALS (SEEDLINGS) POTTED ON 7X7X11 POLY ETHELENE BAG FOR THE ESTABLISHMENT OF BAMBOO PLANTATION AT ALAMINOS CITY, PANGASINAN.**

1. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN**, through *its Financial Grant from PAGCOR* intends to apply an amount of **Eight Hundred Thousand Pesos Only (Php 800,000.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **SUPPLY AND DELIVERY OF TWENTY THOUSAND (20,000) PIECES BAMBOO PLANTING MATERIALS (SEEDLINGS) POTTED ON 7X7X11 POLY ETHELENE BAG FOR THE ESTABLISHMENT OF BAMBOO PLANTATION AT ALAMINOS CITY, PANGASINAN.**

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** now invites bids for the **SUPPLY AND DELIVERY OF TWENTY THOUSAND (20,000) PIECES BAMBOO PLANTING MATERIALS (SEEDLINGS) POTTED ON 7X7X11 POLY ETHELENE BAG FOR THE ESTABLISHMENT OF BAMBOO PLANTATION AT ALAMINOS CITY, PANGASINAN.** Delivery of the Goods is required within **fifteen (15) calendar days upon receipt of the Notice to Award.** Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** and inspect the Bidding Documents at the address given below from **August 8, 2013 – August 27, 2013.**
5. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** will hold a Pre-Bid Conference on **August 15, 2013, 9:30 A.M** at **BAC Office (Former COA Office), City Hall Building, Alaminos City, Pangasinan**, which shall be open only to all interested parties who have purchased the Bidding Documents.
6. A complete set of Bidding Documents may be purchased by interested Bidders upon payment of a non refundable fee for the Bidding Documents in the amount of **Eight Hundred Pesos Only (Php 800.00)** at the BAC Secretariat, Budget Office, Alaminos City, Pangasinan.
7. Bids must be delivered on or before **August 27, 2013, 9:00 A.M.** at **BAC Office (Former COA Office), City Hall Building, Alaminos City, Pangasinan.** All bids must be accompanied by a bid security in any of the acceptable forms in the amount as stated in ITB Clause 18.1. Late bids shall not be accepted.

Bid opening shall be on **August 27, 2013, 9:30AM** at **BAC Office (Former COA Office), City Hall Building, Alaminos City, Pangasinan.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address above.

8. The bid security shall be in the following amount:
- The amount of **Sixteen Thousand Pesos Only (Php 16,000.00)** or [ 2% of ABC], if bid security is in cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit;
  - The amount of **Forty Thousand Peso Only (Php 40,000.00)** or [5% of ABC] if bid security is in Surety Bond; or
  - Any combination of the foregoing proportionate to the share of form with respect to total amount of security.
9. The winning bidder shall be paid only after the issuance of Acceptance Report by the City.
10. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
