Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** now invites bids for the **PROCUREMENT OF VARIOUS COMMODITIES TO BE USED FOR THE SUPPLEMENTARY FEEDING OF DAY CARE CHILDREN OF ALAMINOS CITY, PANGASINAN**. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
2. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.  
  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** and inspect the Bidding Documents at the address given below from **August 8 – August 27, 2013**.
5. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** will hold a Pre-Bid Conference on **August 15, 2013, 9:30 A.M at BAC Office (Former COA Office), City Hall Building, Alaminos City, Pangasinan**, which shall be open only to all interested parties who have purchased the Bidding Documents.

6. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **One Thousand Nine Hundred Eighty Pesos Only (Php 1,980.00)**.

7. Bids must be delivered on or before **August 27, 2013, 9:00 A.M.** at **BAC Office, (Former COA Office) City Hall Building, Alaminos City, Pangasinan**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **August 27, 2013, 9:30AM** at **BAC Office (Former COA Office), City Hall Building, Alaminos City, Pangasinan**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. To be eligible prospective bidders shall be in the industry for **at least 2 years**.

Delivery schedule will be provided by the City Social Welfare and Development Office after the receipt of Notice to Award.

In order to promote livelihood to locally grown producers/farmers of the City, the winning bidder shall procure goods from the list of local producers/farmers provided by City Agriculture Office.

9. The bid security shall be in the following amount:

- The amount of **Thirty Nine Thousand Six Hundred Pesos Only (Php 39,600.00)** or [2% of ABC], if bid security is in cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit;
- The amount of **Ninety Nine Thousand Pesos Only (Php 99,000.00)** or [5% of ABC] if bid security is in Surety Bond; or
- Any combination of the foregoing proportionate to the share of form with respect to total amount of security.

10. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
