INVITATION TO BID FOR THE RENOVATION/UPGRADING OF PLAZA MARCELO OCHAVE AND CHILDREN'S PARK (PHASE II), BRGY. POBLACION, ALAMINOS CITY, PANGASINAN

1. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN**, through *its 20% Development Fund (DF)* intends to apply an amount of ***Eleven Million Two Hundred Ninety Nine Thousand Nine Hundred Seventy Seven Pesos and Forty Four Centavos (Php 11,299,977.44)*** being the Approved Budget for the Contract (ABC) for payment under the contract for the **RENOVATION/UPGRADING OF PLAZA MARCELO OCHAVE AND CHILDREN'S PARK (PHASE II), BRGY. POBLACION, ALAMINOS CITY, PANGASINAN**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** now invites bids for the **RENOVATION/UPGRADING OF PLAZA MARCELO OCHAVE AND CHILDREN'S PARK (PHASE II), BRGY. POBLACION, ALAMINOS CITY, PANGASINAN**.¹ Completion of the Works requires **(One Hundred Eighty) 180 Calendar Days**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** and inspect the Bidding Documents at the address given below from ***February 28 – March 19, 2013***.
5. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** will hold a Pre-Bid Conference *on March 7, 2013 at 9:30 A.M* at **Conference Room, 2nd Floor Alaminos City Hall Building, Alaminos City, Pangasinan**, which shall be open only to all interested parties who have purchased the Bidding Documents.
6. A complete set of Bidding Documents may be purchased by interested Bidders upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Twenty Five Thousand Pesos (Php 25,000.00)** at the BAC Secretariat, Budget Office, Alaminos City, Pangasinan.
7. Bids must be delivered on or before **March 19, 2013 at 9:00 A.M.** at **Conference Room, 2nd Floor, Alaminos City Hall Building, Alaminos City, Pangasinan**. All bids must be accompanied by a bid security in any of the acceptable forms in the amount as stated in ITB Clause 18. Late bids shall not be accepted.

¹ A brief description of the scope of Works should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

Bid opening shall be on **March 19, 2013 at 9:30AM at Conference Room, 2nd Floor, Alaminos City Hall Building, Alaminos City, Pangasinan.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address above.

8. The bid security shall be in the following amount:
 - The amount of **Two Hundred Twenty Five Thousand Nine Hundred Ninety Nine Pesos and Fifty Five Centavos (Php 225,999.55)** or *[2% of ABC]*, if bid security is in cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit;
 - The amount of **Five Hundred Sixty Four Thousand Nine Hundred Ninety Eight Pesos and Eighty Seven Centavos (Php 564,998.87)** or *[5% of ABC]* if bid security is in Surety Bond; or
 - Any combination of the foregoing proportionate to the share of form with respect to total amount of security.
9. The winning bidder is entitled an advance payment of 15% of the contract and the remaining balance shall be paid by the City only after the issuance of Certificate of Project Completion by the City.
10. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
