INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF 6,846 CU.M. AGGREGATE BASE COURSE FOR THE REGRAVELLING OF VARIOUS BARANGAY ROADS AT VARIOUS BARANGAYS, CITY OF ALAMINOS, PANGASINAN

1. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN**, through *its Development Fund (DF)*¹ intends to apply the sum **Two Million Seven Hundred Thirty Eight Thousand Four Hundred Pesos (Php 2,738,400.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **SUPPLY AND DELIVERY OF 6,846 CU.M. AGGREGATE BASE COURSE FOR THE REGRAVELLING OF VARIOUS BARANGAY ROADS AT VARIOUS BARANGAYS, CITY OF ALAMINOS, PANGASINAN**

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** now invites bids for the **SUPPLY AND DELIVERY OF 6,846 CU.M. AGGREGATE BASE COURSE FOR THE REGRAVELLING OF VARIOUS BARANGAY ROADS AT VARIOUS BARANGAYS, CITY OF ALAMINOS, PANGASINAN**. Delivery of the Goods is required within **fifty (50) calendar days upon receipt of the Notice to Award**. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** and inspect the Bidding Documents at the address given below from **January 17 – February 11, 2013**.
5. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** will hold a Pre-Bid Conference *on January 28, 2013 at 9:30 A.M* at **Conference Room, 2nd Floor Alaminos City Hall Building, Alaminos City, Pangasinan**, which shall be open only to all interested parties who have purchased the Bidding Documents.
6. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Two Thousand Seven Hundred Thirty Eight Pesos (Php 2,738.00)**.
7. Bids must be delivered to the BAC Secretariat Office, Budget Office, City Hall Building, Poblacion, Alaminos City, Pangasinan on or before **February 11, 2013 at 9:00 A.M.** at **BAC Secretariat Office, Budget Office, 2nd Floor, Alaminos City Hall Building, Alaminos City, Pangasinan**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.a

¹ In the case of National Government Agencies, the General Appropriations Act and/or continuing appropriations; in the case of GOCCs, GFIs, and SUCs, the Corporate Budget for the contract approved by the governing Boards; in the case of LGUs, the Budget for the contract approved by the respective *Sanggunian*. (Section 5(a), R.A. 9184)

Bid opening shall be on **February 11, 2013 at 9:30AM** at **Conference Room, 2nd Floor, Alaminos City Hall Building, Alaminos City, Pangasinan**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The bid security shall be in the following amount:
 - The amount of **Fifty Four Thousand Seven Hundred Sixty Eight Pesos (PHP 54,768.00)** or [2% of ABC], if bid security is in cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit;
 - The amount of **One Hundred Thirty Six Thousand Nine Hundred Twenty Pesos (Php 136,920.00)** or [5% of ABC] if bid security is in Surety Bond; or
 - Any combination of the foregoing proportionate to the share of form with respect to total amount of security.
9. The winning bidder shall be paid by the City only after the issuance of Acceptance Report by the City.
10. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
