INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF 390 PIECES JETMATIC, 390 PIECES KNAPSACK SPRAYER AND 390 PIECES 1/4 GI PIPE (SCH. 40) TO BE USED AT VARIOUS BARANGAY IN ALAMINOS CITY, PANGASINAN

1. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN**, through *its Development Fund* intends to apply the sum of **Two Million Three Hundred One Thousand (Php 2,301,000.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **SUPPLY AND DELIVERY OF 390 PIECES JETMATIC, 390 PIECES KNAPSACK SPRAYER AND 390 PIECES 1/4 GI PIPE (SCH. 40) TO BE USED AT VARIOUS BARANGAY IN ALAMINOS CITY, PANGASINAN**
2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** now invites bids for the **SUPPLY AND DELIVERY OF 390 PIECES JETMATIC, 390 PIECES KNAPSACK SPRAYER AND 390 PIECES 1/4 GI PIPE (SCH. 40) TO BE USED AT VARIOUS BARANGAY IN ALAMINOS CITY, PANGASINAN**. Delivery of the Goods is required within **fifteen (15) calendar days upon receipt of the Notice to Award**. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** and inspect the Bidding Documents at the address given below from **February 26 – March 22, 2013**.
5. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** will hold a Pre-Bid Conference on **March 8, 2013 at 9:30 A.M** at **Conference Room, 2nd Floor Alaminos City Hall Building, Alaminos City, Pangasinan**, which shall be open only to all interested parties who have purchased the Bidding Documents.
6. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Three Thousand Pesos (Php 3,000.00)**
7. Bids must be delivered to the BAC Secretariat Office, Budget Office, City Hall Building, Poblacion, Alaminos City, Pangasinan on or before **March 22, 2013 at 9:00 A.M.** at **BAC Secretariat Office, Budget Office, 2nd Floor, Alaminos City Hall Building, Alaminos City, Pangasinan**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.a

Bid opening shall be on **March 22, 2013 at 9:30AM** at **Conference Room, 2nd Floor, Alaminos City Hall Building, Alaminos City, Pangasinan**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The bid security shall be in the following amount:
 - The amount of **Forty Six Thousand Twenty Pesos (Php 46,020.00)** or [2% of ABC], if bid security is in cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit;
 - The amount of **One Hundred Fifteen Thousand Fifty Pesos (Php 115,050.00)** or [5% of ABC] if bid security is in Surety Bond; or

- Any combination of the foregoing proportionate to the share of form with respect to total amount of security.
9. The winning bidder shall be paid by the City only after the issuance of Acceptance Report by the City.
 10. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
