### ORDINANCE NO. 2008-04

#### EXPLANATORY NOTE

**WHEREAS**, a petition for tricycle fare rate increase has been filed with this body by the different Local Tricycle Operators and Drivers Association;

**WHEREAS**, since the enactment of Ordinance No. 2005-01 prescribing the tricycle fare rates, the rates therein fixed has not been adjusted;

**WHEREAS**, it is of common knowledge that prices of all goods and prime commodities had gone up including gasoline and motor vehicle spare parts;

**WHEREAS**, said increases had adversely affected the income of all sectors particularly the transport including tricycle operators and drivers;

**WHEREAS**, after weighing the pros and cons of the foregoing petition as a result of conducting a public hearing and several committee hearings, the same has been considered favorably;

**NOW, THEREFORE**, be it

**RESOLVED**, as it is hereby **RESOLVED**, to enact the following ordinance:

**BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD IN SESSION ASSEMBLED**, that

SECTION 1. This ordinance shall be known as: **AN ORDINANCE PRESCRIBING NEW TRICYCLE FARE RATES 2008.**

SECTION 2. The specific provision of Ordinance No. 2005-01 which is the subject for amendment reads as follows:

1. For the first 1.5 kilometers distance regular passengers will have to pay a fare of P6.00.
2. An additional fare of P1.50 for every succeeding 1 kilometer distance or fraction thereof.
3. Twenty percent (20%) discount will be given as privilege for passengers belonging to the group of Senior Citizens, Students, and Disabled Persons.

This schedule of rates shall be posted inside the sidecar for an immediate view of passengers.

The amendments on the immediate preceding provision which shall serve as the new tricycle fare rates 2008 shall read as follows:




