**ORDINANCE NO. 2008-12**

**AN ORDINANCE REQUIRING ALL BANKING INSTITUTIONS WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF ALAMINOS TO INSTALL CCTV CAMERAS AND ALARM SYSTEM AT STRATEGIC PLACES IN THEIR RESPECTIVE ESTABLISHMENTS, IMPOSING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES.**

**EXPLANATORY NOTE**

**WHEREAS**, the City of Alaminos, Province of Pangasinan is a fast growing commercial district and educational center which caters the western towns of the province, including the adjoining towns of the Provinces of Tarlac and Zambales;

**WHEREAS**, among the business sector which continuously increases in number is the banking institution which now comes up to fifteen (15) different banks;

**WHEREAS**, everyone is fully aware to the fact that banking institutions are the favorite target of holdups and robbery activities of various robbery gangs;

**WHEREAS**, banking to such premise, the Bangko Sentral ng Pilipinas (BSP) issued Memorandum Circular 620 ("REVISED RULES AND REGULATIONS ON BANK PROTECTION") wherein it requires all banks to install Close Circuit Television (CCTV) Cameras and Alarm System in their respective establishments, thus, in view thereof, it is the intention of this body to localize the same for further awareness and safety/protective measures;

**NOW, THEREFORE**, upon consultation made with various line agencies, and upon meticulous study, on motion duly seconded;

**BE IT ENACTED IN SESSION ASSEMBLED, THAT:**

**SECTION 1. TITLE OF ORDINANCE:**

**"AN ORDINANCE REQUIRING ALL BANKING INSTITUTIONS WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF ALAMINOS TO INSTALL CCTV CAMERAS AND ALARM SYSTEM AT STRATEGIC PLACES AT THEIR RESPECTIVE ESTABLISHMENTS, IMPOSING PENALTIES FOR VIOLATION THEREOF, AND FOR OTHER PURPOSES."**

**SECTION 2. TERMS AND CONDITIONS** – All banks existing and operating business within the City of Alaminos shall have to install CCTV Cameras and Alarm System at strategic places at their respective business establishments.

**SECTION 3. SCOPE OF COVERAGE** – All banking institutions existing and operating business within the territorial jurisdiction of the city are covered by this ordinance.

**SECTION 4. PENALTY CLAUSE** – Any banking institution found violating this ordinance shall, upon conviction, be fined or punished as follows:

- First Offense = Fine of Php 2,500.00
- Second Offense = Fine of Php 3,500.00
- Third Offense = Fine of Php 5,000.00 or imprisonment of three (3) days on the part of the Bank Manager, or both, fine and imprisonment depending upon the discretion of the court.

**SECTION 5. SEPARABILITY CLAUSE** – Any provision of this ordinance inconsistent with any other ordinances, laws or orders is deem modified or repealed accordingly.

**SECTION 6. EFFECTIVITY CLAUSE** – This ordinance shall take effect immediately upon its approval.
