ORDINANCE NO. 2010-02

AN ORDINANCE PRESCRIBING A SIX (6) YEARS MORATORIUM FOR THE ESTABLISHMENT/CONSTRUCTION OF GASOLINE SERVICE STATION WITHIN THE JURISDICTION OF THE CITY OF ALAMINOS.

Alaminos City, Pangasinan, with some ninety thousand (90,000.00) population, more or less, has an existing twelve (12) gasoline stations operating in the locality, while Dagupan City with some two hundred thousand (200,000) population have seventeen (17) existing gasoline stations.

Based from the recent study, the existing dealers, especially Alaminians, are very much affected by the establishment of too much gasoline stations. While it is true that free enterprise will bring better competition and service to the townspeople and motorists and also more taxes for the city government, the establishment of many gas stations is ruinous competition to investors of the like, especially Alaminians who first invested for the development of our city.

NOW, THEREFORE.....

BE IT ORDAINED IN SESSION ASSEMBLED, That:

SECTION 1. TITLE OF ORDINANCE. This ordinance shall be known as:

"AN ORDINANCE PRESCRIBING A SIX (6) YEARS MORATORIUM FOR THE ESTABLISHMENT/CONSTRUCTION OF GASOLINE SERVICE STATION WITHIN THE JURISDICTION OF THE CITY OF ALAMINOS."

SECTION 2. There is hereby prescribed a six (6) years moratorium in the establishment and/or construction of gasoline/service station within the jurisdiction of the City of Alaminos, Pangasinan.

SECTION 3. No gasoline service station will be established/constructed within the jurisdiction of the City of Alaminos within the six (6) year moratorium period.

SECTION 4. SEPARABILITY CLAUSE. Any provision of this ordinance inconsistent with any other ordinances, laws, decrees and orders is deemed repealed or modified accordingly.




