ORDINANCE NO. 2013-04

AN ORDINANCE ADOPTING REPUBLIC ACT NO. 10172 IMPLEMENTING RULES AND REGULATIONS AS CONTAINED IN ADMINISTRATIVE ORDER NO. 1 SERIES OF 2012 ISSUED BY THE OFFICE OF THE CIVIL REGISTRAR GENERAL, AND RATIFYING THE FEES UNDER RULE 10, "AUTHORITY TO COLLECT FILING AND OTHER FEES" AND FOR OTHER PURPOSES

EXPLANATORY NOTE

WHEREAS, Republic Act No. 10172, otherwise known as, **AN ACT FURTHER AUTHORIZING THE CITY/MUNICIPAL REGISTRAR OR THE CONSUL GENERAL TO CORRECT CLERICAL OR TYPOGRAPHICAL ERRORS IN THE DAY AND MONTH IN THE DATE OF BIRTH OR SEX OF A PERSON APPEARING IN THE CIVIL REGISTER WITHOUT NEED OF A JUDICIAL ORDER, AMENDING FOR THIS PURPOSE ACT NUMBERED NINETY FORTY-EIGHT** was duly enacted by the Congress of the Philippines and approved by his Excellency Simeon Benigno C. Aquino III on August 15, 2012;

WHEREAS, pursuant to Section 2 of Act No. 3753, otherwise known as the "Civil Registry Law", the Office of the Civil Registrar General promulgated the Implementing Rules and Regulations and issued Administrative Order No. 1, series of 2012, for the information, guidance and compliance of all concerned parties;

WHEREAS, RULE 10 of this Administrative Order, "Authority to collect filing and other fees", require the ratification of local legislative body of the fees therein prescribed upon the effectivity of the Executive Order;

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod in session assembled, that:

SECTION 1. TITLE. This ordinance shall be known and called as **"AN ORDINANCE ADOPTING REPUBLIC ACT NO. 10172 IMPLEMENTING RULES AND REGULATIONS AS CONTAINED IN ADMINISTRATIVE ORDER NO. 1 SERIES OF 2012 ISSUED BY THE OFFICE OF THE CIVIL REGISTRAR GENERAL, AND RATIFYING THE FEES UNDER RULE 10, "AUTHORITY TO COLLECT FILING AND OTHER FEES" AND FOR OTHER PURPOSES."**

SECTION 2. DECLARATION OF POLICIES AND PRINCIPLES. The Implementing Rules and Regulations as provided in Administrative Order No. 1, series of 2012 issued by the Office of the Civil Registrar General is hereby adopted in the City of Alaminos, Pangasinan;

SECTION 3. FILING FEES AND OTHER FEES. The prescribed amount of filing fee (Php 3,000.00)



SECTION 4. EFFECTIVITY. This ordinance shall take effect fifteen (15) days upon its approval.


