ORDINANCE NO. 2013-12

ORDINANCE INSTITUTIONALIZING THE PUBLIC EMPLOYMENT SERVICE OFFICE (PESO) AND THE POSITION OF A PUBLIC EMPLOYMENT SERVICE MANAGER IN THE CITY OF ALAMINOS, PANGASINAN.

EXPLANATORY NOTE

WHEREAS, Section 458 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Panlungsod to create and determine positions in the local government unit in response to its needs for the general welfare of the city and its inhabitants;

WHEREAS, Section 3 of R.A. 8659 also provides for the establishment of a Public Employment Service Office and the creation of the position of a Public Employment Manager-Community Training and Employment Coordinator (PESO-CTEC) under the Office of the City Mayor;

WHEREAS, like most regions in the country, the city of Alaminos, Pangasinan felt the impact of unemployment as social problem;

WHEREAS, based on the assessment of the present set-up, this issue is partly due to the absence of an officer who is tasked to undertake measures that would create livelihood activities or coordinate with employment agencies that may provide job opportunities to the unemployed residents;

WHEREAS, to address this issue, this august body deemed it necessary to institutionalize the Public Employment Service Office and create the position of Public Employment Service Manager in the city of Alaminos, Pangasinan;

NOW, THEREFORE, be it ordained, by the Sangguniang Panlungsod of Alaminos City, Pangasinan, in session duly assembled that:

SECTION 1. There shall be established a PUBLIC EMPLOYMENT SERVICE OFFICE (PESO) and the position of a PESO Manager be created in the City of Alaminos, Pangasinan.

SECTION 2. DUTIES AND FUNCTIONS. That the PESO Manager shall be tasked to deliver the following duties, to wit;

- 1) Prepare an Annual Training and Employment Development Plan;
- 2) Encourage employers within the city to submit to the PESO on a regular basis a list of job vacancies to facilitate employment;
- 3) Mobilize locally sourced-out funds;
- 4) Formulate, undertake, monitor and evaluate training and livelihood programs;
- 5) Collate and consolidate reports; and Perform such other duties and functions as maybe prescribed by law or ordinances.

SECTION 3. Qualifications. That the appointee to the position shall possess the following qualifications, to wit;

- 1) He must be a Filipino citizen;
- 2) Resident of the city;
- 3) Of good moral character;
- 4) Holder of a college degree;
- 5) A first grade civil service eligible or its equivalent;
- 6) And those prescribed in the Qualification Standard of the Civil Service other than the above.

SECTION 4. Effectivity. This Ordinance shall take effect upon due approval.




