ORDINANCE NO. 2014-06

ORDINANCE TRANSFERRING/RELOCATING THE CITY MOTOR POOL FROM BARANGAY POBLACION TO BRGY. TANGCARANG, THIS CITY

WHEREAS, the general welfare clause of the 1987 Constitution provides for sufficient considerations to be undertaken to ensure the general welfare of the Filipino people;

WHEREAS, the LGU of Alaminos City in furtherance of the said law continuously take into consideration the general welfare in all its undertakings in the pursuit of sustainable development;

WHEREAS, the City Government of the City of Alaminos had previously established the City Motor Pool at Sabaro, Poblacion, this city, where motor vehicles and heavy equipment owned by the city are being maintained or repaired;

WHEREAS, the City Government realized that to ensure that general welfare of the residents in the area and to make the site more attractive to passing guests and tourist going to the Hundred Islands National Park, there is a need to transfer the City Motor Pool to the property owned by the City at Brgy. Tangcarang;

WHEREAS, a Public Hearing was duly conducted regarding the proposal last April 21, 2014 and the attendees interposes no objection as to its transfer/relocation;

NOW THEREFORE, on motion of Councilor Fatima Ann S. Isla, duly seconded by Councilor Rany S. de Leon and Councilor Rufina J. Gabriel;

Be it ordained by the Sangguniang Panlungsod in session assembled, That:

The City Motor Pool be transferred/relocated from Barangay Poblacion to Barangay Tangcarang, this city.

This ordinance shall take effect upon approval.




