### ORDINANCE NO. 2014-08

#### ORDINANCE OPENING/ESTABLISHING A CHILDREN'S PARK AND ACTIVITY CENTER AT THE FORMER LOCATION OF THE CITY MOTOR POOL AT SABARO STREET, POBLACION, THIS CITY

**WHEREAS**, RULE VIII, Article 43 of the IRR of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides, "An LGU may, through an ordinance, permanently or temporarily close or open any road, alley, park or square within its jurisdiction";

**WHEREAS**, to provide additional recreational facility and activity center in the city for residents and tourist alike, it is timely to open/establish a children's park and activity center in the City of Alaminos;

**WHEREAS**, the city Motor Pool will be relocated/transferred to Brgy. Tangarang pursuant to City Ordinance No. 2014-06 duly enacted by this august body;

**WHEREAS**, to maximize the use of government property for the general welfare of the people, it will be opened/established at the property of the city government at Sabaro Street, Poblacion, this City which is the former location of the city Motor Pool;

**WHEREFORE**, premises considered and on motion of Councilor Fatima Ann S. Isla duly seconded by Councilor Rany S. de Leon and Liga ng mga Barangay President Salvador C. Camba

Be it ordained by the Sangguniang Panlungsod of the city of Alaminos, in session duly assembled to open/establish a children's park and activity center at the former location of the city Motor Pool at Sabaro Street, Poblacion, this city.





