**ORDINANCE NO. 2014-19**

**ORDINANCE SPECIFICALLY IDENTIFYING THE OTHER DEVELOPMENT PROJECTS APPROVED UNDER CITY ORDINANCE NO. 2014-10, DATED JUNE 10, 2014 AS CONVERSION OF DON LEOPOLDO SISON AUDITORIUM TO DON LEOPOLDO SISON CONVENTION CENTER, PROVISION OF ELECTRONIC BILLBOARD FOR DON LEOPOLDO SISON CONVENTION CENTER, SOUND SYSTEM AT THE DON LEOPOLDO SISON CONVENTION CENTER AND ROOFING SYSTEM OF PLAZA ENRIQUE BRAGANZA WHICH WILL BE FUNDED FROM THE PROPOSED LOAN FROM THE LAND BANK OF THE PHILIPPINES AMOUNTING TO FIFTY-FIVE MILLION PESOS (PHP55M)**

**WHEREAS**, pursuant to Section 297 and Section 458 of Republic Act 7160, otherwise known as the Local Government Code of 1991, this august body duly enacted Ordinance No. 2014-10, dated June 10, 2014 granting authority to the Honorable City Mayor, Arthur F. Celeste to negotiate and enter into a Loan Agreement with the Land Bank of the Philippines in the amount of One Hundred Seventy Five Million Pesos (Php175M) to fund the face lifting of the Hundred Islands National Park, Redevelopment of Lucap Wharf and other development projects;

**WHEREAS**, in compliance with Land Bank's policy, the City Government of Alaminos need to specifically identify the "other development projects" provided for under Ordinance No. 2014-10;

**WHEREAS**, one of the main thrust of the City Government of Alaminos is development anchored on eco-tourism;

**WHEREAS**, this thrust will be strengthened through infrastructure projects aimed to increase, promote, and sustain tourism related activities;

**NOW THEREFORE**, on motion of Councilor Fatima Ann S. Isla, co-sponsored by Councilor Joseph T. Bacay and Councilor Rany S. De Leon, duly seconded by Councilor Perlito V. Rabago, Councilor Rufina J. Gabriel and Liga ng mga Barangay President Salvador C. Camba;

**BE IT ENACTED**, as it is hereby enacted, by the Sangguniang Panlungsod of the City of Alaminos, in session assembled that:

**SECTION 1.** The other development projects expressly provided for under Ordinance No. 2014-10, dated June 10, 2014 duly enacted by this body be:

1. Conversion of Don Leopoldo Sison Auditorium to Don Leopoldo Sison Convention Center with a Project Cost of Php 42,212,110.42
2. Provision of Electronic Billboard for Don Leopoldo Sison Convention Center amounting to Php 3,200,000.00
3. Sound System at Don Leopoldo Sison Convention Center amounting to Php 4,409,000.00
4. Construction of Roofing System at Plaza Enrique Braganza with a total Project Cost of Php 5,263,840.95

The total project costs of these development projects amounts to Fifty-five Million Eighty-four Thousand Nine Hundred Fifty One Pesos and Thirty-seven centavos (Php 55,084,951.37)

**SECTION 2.** The fund for the implementation of these development projects will be from the loan proceeds from the Land Bank of the Philippines amounting only to Fifty-five Million Pesos(Php 55,000,000.00), the amount of Eighty Four Thousand Nine Hundred Fifty One Pesos and Thirty Seven Centavos(Php 84,951.37) will be the equity of the Local Government Unit of Alaminos City, Pangasinan.

**SECTION 3.** If any part of this ordinance is declared as unconstitutional or unlawful, such declaration shall not affect the other parts or sections hereof and shall remain valid and subsisting.

**SECTION 4.** All ordinances or parts thereof inconsistent with this ordinance shall be deemed repealed or modified accordingly.

**SECTION 5. EFFECTIVITY** - This ordinance shall take effect upon approval.




