ORDINANCE NO. 2015-09

ORDINANCE AMENDING SECTION 36, ARTICLE 5 OF CITY ORDINANCE NO. 2009-04, OTHERWISE KNOWN AS THE COMPREHENSIVE FISHERIES CODE OF THE CITY OF ALAMINOS 2009, ENACTED ON SEPTEMBER 4, 2009 TO INCREASE THE PRESCRIBED AREA OF OYSTER BED FROM SEVENTY TWO (72) SQUARE METERS TO ONE HUNDRED (100) SQUARE METERS PER UNIT AND LESSEN THE PRESCRIBED DISTANCE BETWEEN OYSTER BEDS FROM TEN (10) METERS TO FIVE (5) METERS.

WHEREAS, pursuant to Article 99 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the Sanggunian of this city duly enacted Ordinance No. 2009-04 on September 4, 2009 entitled, "Comprehensive Fisheries Code of the City of Alaminos 2009" in compliance to Section 16.1 of Department of Agriculture Administrative Order No.3, series of 1998;

WHEREAS, after almost five years of implementation, the City Agriculture Office submitted to the Office of the Honorable City Mayor Arthur F. Celeste, a request for possible amendment of City Ordinance No. 2009-04 to accommodate oyster culture modules for Oyster Culture and Production Livelihood Project in identified areas within the City; to showcase Oyster Farm as agri-tourism destinations in the City and to promote eco-friendly mariculture activities;

WHEREAS, the Honorable City Mayor favorably endorsed such request to this august body for consideration;

WHEREAS, upon meticulous study of the merits surrounding the proposed amendment, the same has been found to be in order and in consonance with the Local Government Unit's thrust of sustainable development through eco-tourism;
