ORDINANCE NO. 2015-10

AN ORDINANCE AMENDING SECTION 64 (F), CHAPTER X AND SECTION 69, CHAPTER XI OF CITY ORDINANCE NO. 2013-10, OTHERWISE KNOWN AS "ORDINANCE ENACTING THE ALAMINOS CITY TOURISM CODE OF 2013"

WHEREAS, pursuant to Article 99 of the Implementing Rules and Regulations of Republic Act 7160, otherwise known as the Local Government Code of 1991, this august body duly enacted Ordinance No. 2013-10, series of 2013, otherwise known as "Ordinance enacting the Alaminos City Tourism Code of 2013" as a tool to vigorously promote tourism, stimulate local growth and revenue;

WHEREAS, pursuant to Article 98(1)(i) of the IRR of Republic Act 7160, the said Ordinance was submitted for review to the Sangguniang Panlalawigan which consequently declared City Ordinance No. 2013-10 enacted within the powers of the Sangguniang Panlungsod through its Resolution No. 195-2014, dated April 7, 2014;

WHEREAS, after almost two years of implementation of the said ordinance, the executive branch submitted to this body a request for amendment of Section 64 (F), Chapter X to ease the burden on carrying capacity of the Hundred Islands National Park and foster the protection and preservation of the HINP by changing the tour route, fixing the motorboat rental rates to efficiently showcase the islands and managing guests arrival to avoid congestion especially during peak season;

WHEREAS, Section 69, Chapter XI, "User's Fee", which provides for the collection of an environmental fee of Forty Pesos (Php40.00) per individual upon entry at the HINP shall be amended to exempt bonafide residents of the City of Alaminos from the payment of environmental fee as an incentive for their support in tourism promotion initiatives of the LGU and further instil in every resident the "culture of tourism";

NOW, THEREFORE, on motion of Councilor Margielou Orange D. Humilde, co-author by Councilor Fatima Ann S. Isla, duly seconded by Councilor Jan Marianne R. Fontelera and Councilor Rufina J. Gabriel

BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD IN SESSION DULY ASSEMBLED THAT:

SECTION 1. Section 64 (F), Chapter X of City Ordinance No. 2013-10, otherwise known as "Alaminos City Tourism Code of 2013" shall be amended to read as follows:

F. Rental Rates of Motorboat-For-Hire shall be fixed based on the following schedules:

Boat Size	Tour Type	One-Day Tour w/ Service Boat	Two-Day Tour w/ Service Boat
Small (1-5 passengers)		P1,400.00	P3,000.00
Medium (6-10 passengers)		P1,800.00	P 3,800.00
Large (11-15 passengers)		P2,000.00	P4,500.00

SECTION 2. Section 69, Chapter XI shall include an exempting clause and shall be read as follows:

SECTION 69. USER'S FEES – The City Tourism Office, in coordination with the City Tourism Council, is hereby mandated to collect environmental/activity fees from any person, natural or juridical, who will use the Hundred Islands National Park for any of the following activities:

An environmental fee of Forty Pesos (P40.00) shall be charged to every individual upon entrance to HINP. **A bonafide resident of Alaminos City shall be exempt from payment of environmental fee provided that proof of residency is presented.**

SECTION 3. Repealing Clause. — All provisions of local ordinances, orders, resolutions inconsistent herewith are hereby repealed and/or modified accordingly.

SECTION 4. Separability Clause. — If for any reason any part of this ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 5. Effectivity. — This Ordinance shall take effect in accordance with the provisions of the Local Government Code of 1991.
