ORDINANCE NO. 2015-13

"ORDINANCE PROVIDING FOR THE TEMPORARY CLOSURE OF PORTION OF C.P. GARCIA STREET (BESIDE THE CITY HALL) AND QUINTOS STREET FROM NOVEMBER 24, 2015 TO JANUARY 12, 2016 FOR THE FOOD ZONE AND NIGHT MARKET (TIANGGEHAN SA PASKO)"

EXPLANATORY NOTE

WHEREAS, it has been a practice that during Yuletide season that night market and food zone are being established by the Local Government Unit of Alaminos City within the city central business district to reinforce the festive mood of the holiday season and as an additional attraction for local residents and tourist alike;

WHEREAS, this year the LGU intends to establish a food zone from the corner of Quezon Avenue and C.P. Garcia Street (Beside the City Hall) up to the front of the Post Office and night market dubbed as "Tianggehan sa Pasko" from the corner of San Jose Drive and Quintos Street up to the front of GPC Elementary Department campus from November 24, 2015 to January 12, 2016;

NOW, THEREFORE, on motion of Councilor Perlito V. Rabago, duly seconded by Councilor Joseph T. Bacay

BE IT ENACTED by the Sangguniang Panlungsod in session duly assembled to:

SECTION 1. Temporary close portion of C.P. Garcia Street (Beside the City Hall) and Quintos Street from November 24, 2015 to January 12, 2016 for the Food Zone and Night Market (Tianggehan sa Pasko).

SECTION 2. This ordinance shall take effect upon approval.




