### ORDINANCE NO. 2016-01

**ORDINANCE PROVIDING FOR THE TEMPORARY FULL/PARTIAL CLOSURE OF PORTION OF C.P. GARCIA STREET BETWEEN LEGISLATIVE BUILDING AND SAINT JOSEPH CATHEDRAL (FROM CATHEDRAL GATE TO PASSENGER JEEPNEY PARKING AREA ON THE RIGHT SIDE AND FROM LEGISLATIVE BUILDING ENTRANCE TO THE INTERSECTION OF MONTEMAYOR STREET ON THE LEFT SIDE) FROM FEBRUARY 23, 2016 TO MARCH 31, 2016 FOR BAZAAR/TIANGGE (DRY GOODS STALLS); PORTION OF MONTEMAYOR STREET BESIDE PLAZA AGAPITO BRAGANZA, FROM THE INTERSECTION OF PLAZA ROAD TO THE INTERSECTION OF C.P. GARCIA STREET, LEFT SIDE ONLY, FROM FEBRUARY 23, 2016 TO MARCH 31, 2016 FOR BAZAAR/TIANGGE (DRY GOODS STALLS); PORTION OF C.P. GARCIA STREET, FROM THE INTERSECTION OF QUINTOS STREET TO THE INTERSECTION OF RABAGO STREET, FROM FEBRUARY 23, 2016 TO MARCH 31, 2016 FOR BAZAAR/TIANGGE (FOOD STALLS, BOTH SIDES); PORTION OF C.P. GARCIA STREET BETWEEN ALAMINOS CITY HALL AND PLAZA MARCELO OCHAVE (FROM THE INTERSECTION OF QUEZON AVENUE TO CORNER OF QUINTOS STREET) AND PORTION OF QUINTOS STREET NORTH SIDE OF PLAZA MARCELO OCHAVE (FROM THE INTERSECTION OF C.P. GARCIA STREET TO CORNER OF SAN JOSE DRIVE, RIGHT SIDE ONLY) TO BE USED FOR PARKING, FROM MARCH 17 TO 29, 2016; PORTION OF QUEZON AVENUE, FROM THE INTERSECTION OF VERECIANO STREET TO THE INTERSECTION OF C.P. GARCIA STREET (INFRONT OF NEPO MART ALAMINOS TO ALAMINOS CITY HALL) AND PORTION OF MARCOS AVENUE, FROM LUCKY A DRUG STORE TO QUEZON AVENUE INTERSECTION, FROM 11:00 PM OF MARCH 18, 2016 TO 3:00 AM OF MARCH 21, 2016, FOR STREET DANCING, STREET PARTY AND TALABA (OYSTER) FESTIVAL.**

**WHEREAS**, various activities were scheduled to make the celebration more festive and bring out the artistic talents of youths in the locality like Street Dancing and Street Party;

**WHEREAS**, due to several activities in line with the celebration of the forthcoming 2016 Patronal and City Fiesta, there is a need to temporarily close certain streets or portions thereof to serve as venue for the scheduled activities on certain dates;

**NOW, THEREFORE**, on motion of Councilor Perlito V. Rabago, duly seconded by Councilor Joseph T. Bacay, Councilor Rany S. de Leon, Councilor Fatima Ann S. Isla and Liga ng mga Barangay President, Salvador C. Camba

**BE IT ENACTED** by the Sangguniang Panlungsod in session duly assembled to:

**SECTION 1.** Temporarily close portion of C.P. Garcia Street between Legislative Building and Saint Joseph Cathedral (from Cathedral Gate to Passenger Jeepney Parking Area on the Right Side and from Legislative Building Entrance to the Intersection of Montemayor Street on the left side) from February 23, 2016 to March 31, 2016 for Bazaar/Tiangge (Dry Goods Stalls); portion of Montemayor Street beside Plaza Agapito Braganza, from the Intersection of Plaza Road to the Intersection of C.P. Garcia Street, left side only, from February 23, 2016 to March 31, 2016 for Bazaar/Tiangge (Dry Goods Stalls); portion of C.P. Garcia Street, from the Intersection of Quintos Street to the Intersection of Rabago Street, from February 23, 2016 to March 31, 2016 for Bazaar/Tiangge (Food Stalls, both sides); portion of C.P. Garcia Street between Alaminos City Hall and Plaza Marcelo Ochave (from the Intersection of Quezon Avenue to corner of Quintos Street) and portion of Quintos Street North side of Plaza Marcelo Ochave (from the Intersection of C.P. Garcia Street to Corner of San Jose Drive, Right Side only) to be used for Parking, from March 17 to 29, 2016; portion of Quezon Avenue, from the Intersection of Vereciano Street to the Intersection of C.P. Garcia Street (Infront of Nepo Mart Alaminos to Alaminos City Hall) and portion of Marcos Avenue, from Lucky A Drug Store to Quezon Avenue Intersection, from 11:00 PM of March 18, 2016 to 3:00 AM of March 21, 2016, for Street Dancing, Street Party and Talaba (Oyster) Festival.

**SECTION 2.** This ordinance shall take effect upon approval.
