GARCIA STREET TO CORNER OF VERECIANO STREET AND THE PORTION OF MARCOS AVENUE, FROM THE INTERSECTION OF QUEZON AVENUE (INFRONT OF NEPO MART ALAMINOS) TO CORNER OF M. MONTEMAYOR STREET, FROM 1:00 O'CLOCK IN THE MORNING TO 4:00 O'CLOCK IN THE AFTERNOON OF MARCH 26, 2017, FOR THE WESTERN PANGASINAN STREET DANCING COMPETITION
