**ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF PORTION OF C.P. GARCIA STREET BETWEEN PLAZA MARCELO OCHAVE AND CITY HALL BUILDING (FROM CORNER OF QUEZON AVENUE TO CORNER OF QUINTOS STREET) AND TEMPORARY PARTIAL CLOSURE OF QUINTOS STREET (LEFT SIDE PORTION, FROM CORNER OF C.P. GARCIA STREET TO CORNER OF SAN JOSE DRIVE) FROM NOVEMBER 20, 2017 TO JANUARY 08, 2018 FOR DRY GOODS AND FOOD STALLS**

### EXPLANATORY NOTE
