ORDINANCE NO. 2018-08

AN ORDINANCE INCREASING TRICYCLE FARE IN THE CITY OF ALAMINOS AND AMENDING FOR THIS PURPOSE SECTION 2 OF CITY ORDINANCE NO. 2008-04 OTHERWISE KNOWN AS "THE TRICYCLE FARE RATES OF 2008"

EXPLANATORY NOTE

WHEREAS, the Federations of Tricycle Operators and Drivers in the city submitted their request for tricycle fare increase to the august body thru the office of City Councilor Froebel Ranoy, Chairperson, SP Committee on Transportation;

WHEREAS, committee hearings and a Public Hearing were conducted to study the implications of the proposed fare increase for tricycle in the locality;

WHEREAS, the recent oil price hikes and the implementation of the Tax Reform for Acceleration and Inclusion (TRAIN) Law caused the increase in prices of prime commodities and at the same time affected the income of the transportation sector;

WHEREAS, upon careful perusal of the issue at hand, the august body deemed it proper and timely to grant the request of the Federations of Tricycle Operators and Drivers in the city;

NOW, THEREFORE, on motion of Councilor Froebel A. Ranoy, co-sponsored by Councilor Margielou Orange Humilde-Verzosa and Councilor Perlito V. Rabago, duly seconded by Councilor Carolyn D. Sison, Councilor Joselito O. Fontelera, Councilor Rufina J. Gabriel and Councilor Cirilo B. Radoc;

BE IT ENACTED BY THE SANGGUNIANG PANLUNGSOD OF THE CITY OF ALAMINOS, PANGASINAN IN SESSION DULY ASSEMBLED that

SECTION 1. TITLE - This ordinance shall be known as **THE NEW TRICYCLE FARE RATES OF 2018 OF THE CITY OF ALAMINOS.**

SECTION 2. TRICYCLE FARE RATES -

Section 2 of Ordinance No. 2008-04 which is the subject of amendment, provides a schedule of tricycle fare rates as follows:

The above stated provision under Section 2 of Ordinance No. 2008-04 is hereby amended and a new fare rate is hereby imposed as follows:

1. For Regular Passengers:

Ten (Php 10.00) Pesos shall be charged for the first 1.5 kilometer and an additional fare in the amount of Two Pesos (Php 2.00) Pesos for every succeeding kilometer.

2. For Senior Citizen/PWD/Student:

- Twenty Percent (20%) discount on the actual fare shall be granted to Senior Citizens pursuant to Republic Act 9994 otherwise known as the "Expanded Senior Citizens Act of 2010";
- Twenty Percent (20%) Discount on the actual fare shall be granted to Persons with Disabilities pursuant to Republic Act No. 9442 otherwise known as "An Act Amending the Magna Carta for Disabled Persons and For Other Purposes";
- Twenty Percent Discount (20%) Discount on the actual fare shall be granted to students pursuant to LTFRB Memorandum Circular No. 2017-024 dated 11 October, 2017

SECTION 3. Requirement to avail of the discount provided for under (2) Section 2

Senior Citizens, Persons with Disabilities, Students shall present their respective valid Identification Cards to avail of such discount.

SECTION 4. Proper posting of the new fare rates.

All tricycles for hire with franchise in the City of Alaminos, Pangasinan shall post the New Tricycle Fare Matrix inside the tricycle sidecar within the passenger's view upon the implementation of this ordinance.

SECTION 5. Mandatory imposition of fare rates.

The new fare rate provided for under Section 2 hereof, shall be strictly imposed regardless of whether the tricycle is queuing or carrying only one passenger.

SECTION 6. Separability Clause. Should any provision herein be declared unconstitutional or invalid by a court of competent jurisdiction, the same shall not affect the validity of the other provisions of this ordinance.

SECTION 7. Repealing Clause. All ordinances inconsistent with this ordinance are hereby amended, repealed or modified accordingly.

SECTION 8. Effectivity. This ordinance shall take effect upon approval and compliance with the applicable statutory provisions.
