ORDINANCE NO. 2019-01

ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF PORTION OF G. MONTEMAYOR STREET (EAST SIDE OF DON LEOPOLDO SISON CONVENTION CENTER (DLSCC)), FROM THE INTERSECTION OF QUEZON AVENUE UP TO THE ALAMINOS CITY FIRE STATION (FRONT) AND PORTION OF DIMASALANG STREET (WEST SIDE OF DLSCC) FROM THE INTERSECTION OF QUEZON AVENUE TO THE BACK OF ALAMINOS CITY FIRE STATION FROM 7:00 O'CLOCK IN THE MORNING TO 2:00 O'CLOCK IN THE AFTERNOON FOR THE ASSEMBLY OF WEDDING COUPLES AND PARKING AREA, RESPECTIVELY DURING THE CONDUCT OF KASALANG BAYAN ON FEBRUARY 13, 2019 (WEDNESDAY)

EXPLANATORY NOTE

WHEREAS, as one of the highlights of the celebration of Local Civil Registry month, the City Local Civil Registrar's Office of the City of Alaminos has been conducting the "Kasalang Bayan" as one of the highlights of the occasion, where unmarried couples are given the opportunity to legalize their union for free;

WHEREAS, this year the "Kasalang Bayan" will be conducted on February 13, 2019 at the Don Leopoldo Sison Convention Center where one hundred sixteen (116) couples will be married in a mass wedding ceremony to be officiated by City Mayor Arthur F. Celeste;

WHEREAS, considering the number of people expected to attend in the ceremony, there is a need to close portion of G. Montemayor Street (east side of Don Leopoldo Sison Convention Center), from the intersection of Quezon Avenue up to the Alaminos City Fire Station (front) and portion of Dimasalang Street (west side of DLSCC) from the intersection of Quezon Avenue to the back of Alaminos City Fire Station from 7:00 o'clock in the morning to 2:00 o'clock in the afternoon for the assembly of wedding couples and parking area, respectively during the conduct of 6TH KASALANG BAYAN on February 13, 2019 (Wednesday);

BE IT ENACTED by the Sangguniang Panlungsod in session duly assembled an:
