2. **TEMPORARY PARTIAL CLOSURE OF QUINTOS STREET (FROM CORNER OF C.P. GARCIA STREET TO CORNER OF SAN JOSE DRIVE) FROM NOVEMBER 27, 2019 TO JANUARY 06, 2020 FOR FOOD STALLS; AND**






