ORDINANCE NO. 2020-02

ORDINANCE PROVIDING FOR THE TEMPORARY CLOSURE OF THE FOLLOWING TOURIST SPOTS IN THE CITY OF ALAMINOS, PANGASINAN AS A MEASURE TO COMPLY WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT ADVISORY ISSUED ON MARCH 14, 2020 ON STRINGENT SOCIAL DISTANCING FOR THE MANAGEMENT OF CORONAVIRUS DISEASE (COVID-19) FROM MARCH 18, 2020 TO APRIL 14, 2020, TO WIT:

1. HUNDRED ISLANDS NATIONAL PARK;
2. LUCAP PARK;
3. E-KAWAYAN FACTORY;
4. BUED MANGROVE PARK; AND
5. BOLO BEACH

EXPLANATORY NOTE

WHEREAS, the current threat of COVID-19 in the locality necessitates the implementation of stringent measures to contain the spread of the virus and ensure that the people are protected from such;

WHEREAS, as per report of Dr. Danna May R. Ragudos, Officer-in Charge of the City Health Office, as of March 17, 2020 the City of Alaminos, Pangasinan has one (1) case of Person under Investigation (PUI) and One Thousand Five Hundred Seventy-One (1,571) Persons under Monitoring (PUM);

WHEREAS, one of the recommended measures in containing the spread of this highly contagious disease is social distancing which was reiterated in national government agencies issuances;

WHEREAS, pursuant to SP Resolution No. 2020-56, series of 2020, the City of Alaminos, Pangasinan was placed under community quarantine;

WHEREAS, this august body intends to adopt the social distancing as provided for under DILG Advisory, dated March 14, 2020;

BE IT ORDAINED BY THE CITY COUNCIL OF ALAMINOS CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. SECTION 2. This ordinance shall take effect upon approval.


