ORDINANCE NO. 2020-03

ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF THE FOLLOWING BARANGAY ROADS EFFECTIVE IMMEDIATELY UP TO APRIL 14, 2020 TO MONITOR THE ENTRY AND EXIT OF PEOPLE AND VEHICLES IN THE CITY OF ALAMINOS, PANGASINAN AS A PRECAUTIONARY MEASURE TO CURB THE SPREAD OF COVID-19, AND ENJOINING THE SANGGUNIANG BARANGAY OF THE CONCERNED BARANGAYS, THE PHILIPPINE NATIONAL POLICE, ALAMINOS CITY AND THE PUBLIC ORDER AND SAFETY OFFICE TO IMPLEMENT AND MONITOR STRICT COMPLIANCE TO THIS ORDINANCE, TO WIT:

EXPLANATORY NOTE

WHEREAS, in response to the threat of Covid-19, declared as pandemic by the World Health Organization, President Rodrigo Roa Duterte duly issued Presidential Proclamation No. 922 dated March 8, 2020 declaring a State of Public Health Emergency Throughout the Philippines;

WHEREAS, the Office of Executive Secretary issued a Memorandum dated March 16, 2020 placing the entire Luzon under Enhanced Community Quarantine and provides for stringent social distancing measures;

WHEREAS, the City of Alaminos recently recorded its first confirmed case of COVID-19;

WHEREAS, to further strengthen the monitoring of the entry and exit of people and vehicles in the locality, there is a need to limit the entry and exit points in the city;

WHEREAS, Article 45 (a) of the Implementing Rules and Regulations of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the LGU may temporarily close any national or local road, alley, park, or square during actual emergency xxx;

WHEREFORE, upon due consideration of the merits surrounding the issue and on motion of Councilor Cirilo B. Radoc, duly seconded by Councilor Dahlia M. de Leon and Councilor Froebel A. Ranoy,

BE IT ENACTED by the Sangguniang Panlungsod in session duly assembled an:

SECTION 1. 
SECTION 3. This ordinance shall take effect upon approval.
