ORDINANCE NO. 2020-06

ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE TO ALL TYPES OF VEHICLES EXCEPT DELIVERY VEHICLES AND MOTORCYCLES OF NEPO MART AND CAMAR MARKET EMPLOYEES WITH VALID IDENTIFICATION CARDS, PORTION OF VERECIANO STREET (EAST PORTION OF NEPO MART), F. REINOSO STREET (WEST PORTION OF NEPO MART) AND M. SISON STREET FROM APRIL 22, 2020 TO APRIL 30, 2020 AND FOR ANY EXTENSION OF THE ENHANCED COMMUNITY QUARANTINE FOR THE IMPLEMENTATION OF THE (ECQ) GUIDELINES ESPECIALLY ON CHECKING/VERIFICATION OF QUARANTINE PASS, COMPLIANCE TO DAILY MARKET TIME SCHEDULE AND SOCIAL DISTANCING

EXPLANATORY NOTE

WHEREAS, Presidential Proclamation No. 922, dated 08 March 2020, declared a State of Public Health Emergency over the entire country, and Proclamation No. 929, dated 16 March 2020, declared a State of Calamity throughout the Philippines due to COVID-19 and further imposed an Enhanced Community Quarantine throughout Luzon;

WHEREAS, Executive Order (EO) No. 0015-2020, dated 23 March 2020, by Governor Amado I. Espino III, Governor of Pangasinan placed the whole Province of Pangasinan under Extreme Enhanced Community Quarantine (EECQ);

WHEREAS, various issuances of concerned national and local government authorities provide for protocols and guidelines for the management and control of COVID-19 such as implementation of quarantine pass, market time schedule and social distancing;

WHEREAS, one of the identified measures to strictly implement and monitor the provisions of the above stated issuances, there is a need to temporarily close portion of Vereciano Street; F. Reinoso Street and M. Sison Street in the City of Alaminos, Pangasinan to all types of vehicles except delivery vehicles and motorcycles of employees of Nepo Mart and Camar market with valid identification cards;

WHEREFORE, upon due consideration of the merits surrounding the issue and on motion of Councilor Verna S. D. Rabago, duly seconded by Councilor Michelle S. Segundera, Councilor Apolonia G. Bacay Councilor Carolyn D. Sison, and LBP Raul B. Bacy,

BE IT ENACTED by the Sangguniang Panlungsod in session duly assembled an:

SECTION 1.
