**ORDINANCE NO. 2020-09**

**ORDINANCE PROVIDING FOR THE EXTENSION OF THE PERIOD OF TEMPORARY CLOSURE OF THE FOLLOWING TOURIST SPOTS IN THE CITY OF ALAMINOS, PANGASINAN AS A MEASURE TO COMPLY WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT ADVISORY ISSUED ON MARCH 14, 2020 ON STRINGENT SOCIAL DISTANCING FOR THE MANAGEMENT OF CORONAVIRUS DISEASE (COVID-19) UNTIL THE LIFTING OF THE COMMUNITY QUARANTINE IN THE CITY, TO WIT:**

1. HUNDRED ISLANDS NATIONAL PARK;
2. LUCAP PARK;
3. E-KAWAYAN FACTORY;
4. BUED MANGROVE PARK; AND
5. BOLO BEACH

**EXPLANATORY NOTE**

**WHEREAS**, the current threat of COVID-19 in the locality necessitates the implementation of stringent measures to contain the spread of the virus and ensure that the people are protected from such;

**WHEREAS**, one of the recommended measures in containing the spread of this highly contagious disease is social distancing which was reiterated in national government agencies' issuances;

**WHEREAS**, in compliance to the duly issued guidelines and protocols of the duly constituted authorities, this august body duly enacted Ordinance No. 2020-02 providing for the temporary closure of tourist spots in the city from March 18, 2020 to April 14, 2020;

**WHEREAS**, on 24 April 2020, President Rodrigo Roa Duterte announced the extension of the enhanced community quarantine to certain provinces in the country, including the Province of Pangasinan, until May 15, 2020;

**WHEREAS**, in conformity with the announcement of the President, this august body duly enacted Ordinance No. 2020-07, series of 2020 providing for the extension of the period of temporary closure of the tourist spots in the city until May 15, 2020 guided by the guidelines and protocols for communities under Enhanced Community Quarantine;

**WHEREAS**, the recent pronouncement by the Inter-Agency Task Force for the Management of Emerging Infectious Disease thru IATF Resolution No. 37, series of 2020 placed the Province of Pangasinan from Enhanced Community Quarantine (ECQ) to General Community Quarantine (GCQ);

**WHEREAS**, the guidelines and protocols under General Community Quarantine provides for the same stringent measure for social distancing and is therefore imperative to extend the temporary closure of tourist spots in the city;






