ORDINANCE NO. 2020-10

ORDINANCE PROVIDING FOR THE EXTENSION OF THE TEMPORARY FULL CLOSURE OF THE FOLLOWING BARANGAY ROADS UNTIL THE COMMUNITY QUARANTINE IN THE CITY IS LIFTED, TO WIT:

1. **BARANGAY MAAWI:**
 - A- PSU-BOLANEY-MAAWI ROAD;
 - B- MAAWI ROAD GOING TO TAGUDIN, MABINI;
 - C- MAAWI ROAD GOING TO LUNA, MABINI
2. **BARANGAY BALAYANG:**
 - A- BALAYANG ROAD GOING TO LUNA, MABINI;
3. **BARANGAY DULACAC:**
 - A- DULACAC ROAD GOING TO LUNA, MABINI;
 - B- DULACAC ROAD GOING TO SITIO BALLAG;
4. **BARANGAY TAWIN-TAWIN:**
 - A- ROAD AT SITIO SULPUR GOING TO GARITA, BANI;
5. **BARANGAY STA. MARIA:**
 - A- STA. MARIA ROAD GOING TO SAN MIGUEL, BANI;

WHEREAS, in response to the threat of Covid-19, declared as pandemic by the World Health Organization, President Rodrigo Roa Duterte duly issued Presidential Proclamation No. 922 dated March 8, 2020 declaring a State of Public Health Emergency throughout the Philippines;

WHEREAS, on 24 April, 2020, President Duterte announced the extension of the enhanced community quarantine of certain provinces in the country, including the Province of Pangasinan;

WHEREAS, to conform to national government's issuances, this august body duly enacted Ordinance No. 2020-03 providing for the temporary closure of certain barangay roads purposely to monitor and restrict the movement of people and curb the rate of transmission of Coronavirus Disease 19 in the locality, guided by the guidelines and protocol for areas under Enhanced Community Quarantine;

WHEREAS, upon the declaration of the extension of the enhanced community quarantine in the city, the august body enacted Ordinance No. 2020-08 providing for the extension of the period of temporary closure of the roads until May 15, 2020;

WHEREAS, the recent pronouncement by the Inter-Agency Task Force for the Management of Emerging Infectious Disease thru IATF Resolution No. 37, series of 2020 placed the Province of Pangasinan from Enhanced Community Quarantine (ECQ) to General Community Quarantine (GCQ);

WHEREAS, with the same intent and guided by Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the august body deemed it proper to again extend the temporary closure of the same roads until the community quarantine is lifted;

NOW, THEREFORE, on motion of Councilor Cirilo B. Radoc, duly seconded by Councilor Oscar A. Boling, Councilor Verna S. D. Rabago, Councilor Froebel A. Ranoy, Councilor Carolyn D. Sison and LBP Raul B. Bacay,

BE IT ENACTED by the Sangguniang Panlungsod in session duly assembled an:


