**ORDINANCE NO. 2022-13**

**ORDINANCE PRESCRIBING FEES FOR MEDICINES, SUPPLIES AND SERVICES PROVIDED TO PATIENTS AT THE ALAMINOS CITY DIALYSIS CLINIC, AMENDING FOR THIS PURPOSE SECTION 5 OF ORDINANCE NO. 2021-02 AND REPEALING ORDINANCE NO. 2022-07 ENACTED ON 27 JUNE 2022 OF THE CITY OF ALAMINOS, PANGASINAN**

**WHEREAS**, Section 11 of Article XIII of the 1987 Philippine Constitution partly provides that *“the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all people at affordable cost. There shall be priority for the needs of underprivileged sick, elderly, disabled, women, and children. xxx”*

**WHEREAS**, pursuant to SP Resolution No. 2018-17, the august body duly endorsed to the Department of Health- Health Facilities and Services Regulatory Bureau the establishment of the Alaminos City Dialysis Clinic which was duly approved;

**WHEREAS**, the Alaminos City Hemodialysis/Renal Center was consequently constructed and opened to accept dialysis patients on 24 August 2021;

**WHEREAS**, the fees for dialysis treatment services at the Alaminos City Hemodialysis/Renal Center were duly imposed pursuant to City Ordinance No. 2021-02 duly enacted on 26 January 2021;

**WHEREAS**, to provide immediate access to needed medicines and supplies of patients undergoing dialysis at the Alaminos City Hemodialysis/Renal Center, there is a clamor that the center will maintain stocks of medicines and supplies;

**WHEREAS**, to ensure reasonable fees for medicines and supplies at the center as well as to provide legal basis for collection, the august body enacted Ordinance No. 2022-07 on 27 June 2022;

**WHEREAS**, due to some underlying circumstances, the required Public Hearing for the enactment of Ordinance No. 2022-07 was not conducted;

**WHEREAS**, as per recommendation of the Sangguniang Panlalawigan the said ordinance was withdrawn to undergo the required process in the enactment of an ordinance duly provided for under Sections 187 and 188 of Republic Act 7160, otherwise known as the "Local Government Code of 1991";

**WHEREAS**, after undergoing the required process in the enactment of an ordinance, there is a need to repeal Ordinance No. 2022-07 to update its number and reflecting therein the names of the current members of the Sangguniang Panlungsod of the City of Alaminos, Pangasinan;

**NOW, THEREFORE**, on motion of Councilor Michelle S. Segundera, duly seconded by all members present

**BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF THE CITY OF ALAMINOS, PANGASINAN IN REGULAR SESSION ASSEMBLED:**

**SECTION 1. TITLE.** — This Ordinance shall be cited or known as "**Ordinance Prescribing Fees for Medicines, Supplies and Services Provided to Patients at the Alaminos City Dialysis Clinic.**"

**SECTION 2. AMENDED SECTION.** — Section 5 of City Ordinance No. 2021-02 provides for the rate of dialysis treatment services which read as follows:

**SECTION 5. RATE OF DIALYSIS TREATMENT SERVICE FEE:** *The rate of dialysis treatment service shall be as follows:*

*New :PhP 3,250.00 (inclusive of dialyzer, bloodlines and doctor's fee)*  
*Re-use:PhP 2,600.00 (inclusive of dialyzer, bloodlines and doctor's fee)*  
*PCSO :PhP 2,600.00 charge to PCSO*

The above stated provision is hereby amended to include the prescribed rates of medicines and supplies at the Alaminos City Dialysis Clinic, to read as follows:

**SECTION 5.** The following are the prescribed fees at the Alaminos City Dialysis Clinic.

**I. RATE OF DIALYSIS TREATMENT SERVICE FEE:**

New : PhP 3,250.00 (inclusive of dialyzer, bloodlines and doctor's fee)  
 Re-use : PhP 2,600.00 (inclusive of dialyzer, bloodlines and doctor's fee)  
 PCSO : PhP 2,600.00 charge to PCSO
