EXPLANATORY NOTE

WHEREAS, Article 43 of the Implementing Rules and Regulations of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that *"An LGU, may, through an ordinance, permanently or temporarily close or open any road, alley, park, or square within its jurisdiction;"*

WHEREAS, Article 45 (a) of the Implementing Rules and Regulations of the same Code further provides in part, that *"Any national or local road, alley, park, or square may be temporarily closed during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs, or undertaking of public works and highways, telecommunications, and waterworks projects xxx;*

WHEREAS, as a long-held tradition, the City of Alaminos, Pangasinan has been celebrating the Hundred Islands Festival during the month of March of every year which also coincides with the city fiesta;

WHEREAS, since many activities and events were lined-up for the occasion, there is a need to temporarily close portions of roads and plaza within the central business district to serve as venues of the activities and events;

NOW, THEREFORE, on motion of Councilor Verna S. D. Rabago, duly seconded by all members present

BE IT ENACTED by the Sangguniang Panlungsod in session duly assembled that:

SECTION 1. Title - AN ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF THE FOLLOWING STREETS AND PLAZA IN THE CITY OF ALAMINOS, PANGASINAN, TO WIT:

SECTION 2. General Provision - In line with the celebration of the Hundred Islands Festival 2023, the following roads and plaza are hereby temporarily closed for the specified duration, to wit:

1. PORTION OF C.P. GARCIA STREET (BETWEEN PLAZA MARCELO OCHAVE AND ALAMINOS CITY HALL BUILDING) AND PORTION OF QUINTOS STREET (FROM INTERSECTION OF QUEZON AVENUE AND C.P. GARCIA STREET TO INTERSECTION OF C.P. GARCIA STREET AND QUINTOS STREET AND FROM INTERSECTION OF C.P. GARCIA STREET AND QUINTOS STREET TO INTERSECTION OF QUINTOS STREET AND SAN JOSE DRIVE) FROM FEBRUARY 28, 2023 TO APRIL 05, 2023 FOR THE ESTABLISHMENT OF FIESTA BAZAAR (DRY GOODS STALLS AND FOOD STRIP); AND












SECTION 3. Effectivity Clause - This ordinance shall take effect upon approval.
