SISON STREET AND CORNER OF F. REINOSO STREET), PORTION OF F. REINOSO STREET (FROM THE INTERSECTION OF M. SISON STREET TO CORNER OF T. RAPATALO/PALALI STREET), PORTION OF T. RAPATALO/PALALI STREET (FROM THE INTERSECTION OF F. REINOSO STREET TO CORNER OF C. P. GARCIA STREET), PORTION OF C. P. GARCIA STREET (FROM THE INTERSECTION OF T. **EXPLANATORY NOTE**

**WHEREAS**, Article 43 of the Implementing Rules and Regulations of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that *"An LGU, may, through an ordinance, permanently or temporarily close or open any road, alley, park, or square within its jurisdiction."*

**WHEREAS**, Article 45 (a) of the Implementing Rules and Regulations of the same Code further provides in part, that *"Any national or local road, alley, park, or square may be temporarily closed during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs, or undertaking of public works and highways, telecommunications, and waterworks projects xxx;*

**WHEREAS**, as a long-held tradition, the City of Alaminos, Pangasinan has been celebrating the Hundred Islands Festival during the month of March of every year which also coincides with the city fiesta;

**WHEREAS**, since many activities and events were lined-up for the occasion, there is a need to temporarily close portions of roads and plaza within the central business district to serve as venues of the activities and events;

**NOW, THEREFORE**, on motion of Councilor Verna S. D. Rabago, duly seconded by all members present

**BE IT ENACTED** by the Sangguniang Panlungsod in session duly assembled that:

**SECTION 1. Title - AN ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF THE FOLLOWING STREETS IN THE CITY OF ALAMINOS, PANGASINAN, TO WIT:**

*PORCION OF QUEZON AVENUE (FROM THE FRONT OF PNP STATION TO CORNER OF VERECIANO STREET); PORCION OF VERECIANO STREET (FROM THE INTERSECTION OF QUEZON AVENUE TO THE CORNER OF M. SISON STREET AND CORNER OF F. REINOSO STREET), PORCION OF F. REINOSO STREET (FROM THE INTERSECTION OF M. SISON STREET TO CORNER OF T. RAPATALO/PALALI STREET), PORCION OF T. RAPATALO/PALALI STREET (FROM THE INTERSECTION OF F. REINOSO STREET TO CORNER OF C. P. GARCIA STREET), PORCION OF C. P. GARCIA STREET (FROM THE INTERSECTION OF T. RAPATALO/PALALI STREET TO CORNER OF B. REINOSO STREET), PORCION OF B. REINOSO STREET (FROM THE INTERSECTION OF C. P. GARCIA STREET TO CORNER OF SAN JOSE DRIVE), AND PORCION OF SAN JOSE DRIVE*

**SECTION 2. General Provision** - In line with the celebration of the Hundred Islands Festival 2023, the following streets are hereby temporarily closed for the specified duration, to wit:

*Portion of Quezon Avenue (from the front of PNP Station to corner of Vereciano Street); portion of Vereciano Street (from the intersection of Quezon Avenue to the corner of M. Sison Street and corner of F. Reinoso Street), portion of F. Reinoso Street (from the intersection of M. Sison Street to corner of T. Rapatalo/Palali Street), portion of T. Rapatalo/Palali Street (from the intersection of F. Reinoso Street to corner of C. P. Garcia Street), portion of C. P. Garcia Street (from the intersection of T. Rapatalo/Palali Street to corner of B. Reinoso Street), portion of B. Reinoso Street (from the intersection of C. P. Garcia Street to corner of San Jose Drive), and portion of San Jose Drive (from the intersection of B. Reinoso Street to corner of Quezon Avenue/A. Bonifacio Monument) on March 19, 2023 from 5:30 o'clock to 9:00 o'clock in the morning (5:30AM - 9:00AM) to serve as parade route for the Civic Military and Farmers' Float Parade.*

**SECTION 3. Effectivity Clause** - This ordinance shall take effect upon approval.
