**ORDINANCE NO. 2023-10**

**AN ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF PORTION OF SAN JOSE DRIVE (FROM THE INTERSECTION OF QUINTOS STREET TO CORNER OF QUEZON AVENUE/BETWEEN PLAZA MARCELO OCHAVE AND PLAZA ENRIQUE BRAGANZA) ON MARCH 19, 2023 FROM NINE O’CLOCK IN THE MORNING TO ONE O’CLOCK IN THE AFTERNOON (9:00 AM TO 1:00 PM) TO SERVE AS TEMPORARY PARKING AREA**

**EXPLANATORY NOTE**

**WHEREAS**, Article 43 of the Implementing Rules and Regulations of Republic Act 7160 otherwise known as the Local Government Code of 1991 provides that *“An LGU, may, through an ordinance, permanently or temporarily close or open any road, alley, park, or square within its jurisdiction;”*

**WHEREAS**, Article 45 (a) of the Implementing Rules and Regulations of the same Code further provides in part, that *“Any national or local road, alley, park, or square may be temporarily closed during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs, or undertaking of public works and highways, telecommunications, and waterworks projects xxx;”*

**WHEREAS**, as a long-held tradition, the City of Alaminos, Pangasinan has been celebrating the Hundred Islands Festival during the month of March of every year, which also coincides with the city fiesta;

**WHEREAS**, since many activities and events are lined-up for the occasion, there is a need to temporarily close portions of roads and plaza within the central business district to serve as venues of the activities and events;

**NOW, THEREFORE**, on motion of Councilor Verna S. D. Rabago, duly seconded by all members present

**BE IT ENACTED** by the Sangguniang Panlungsod in session duly assembled that:

**SECTION 1. Title** - AN ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF PORTION OF SAN JOSE DRIVE (FROM THE INTERSECTION OF QUINTOS STREET TO CORNER OF QUEZON AVENUE/BETWEEN PLAZA MARCELO OCHAVE AND PLAZA ENRIQUE BRAGANZA) ON MARCH 19, 2023 FROM NINE O'CLOCK IN THE MORNING TO ONE O'CLOCK IN THE AFTERNOON (9:00 AM TO 1:00 PM) TO SERVE AS TEMPORARY PARKING AREA.

**SECTION 2. General Provision** - In line with the celebration of the Hundred Islands Festival 2023, portion of San Jose Drive (from the intersection of Quintos Street to corner of Quezon Avenue/between Plaza Marcelo Ochave and Plaza Enrique Braganza) is hereby temporarily closed on March 19, 2023 from nine o'clock in the morning to one o'clock in the afternoon (9:00 am to 1:00 pm) to serve as temporary parking area in line with the conduct of the Civic Military and Farmers Float Parade.

**SECTION 3. Effectivity Clause** - This ordinance shall take effect upon approval.
