**AN ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF:**

1. PORTION OF QUEZON AVENUE (FROM THE INTERSECTION OF BRAGANZA STREET TO THE INTERSECTION OF SAN JOSE DRIVE-FRONT OF DON LEOPOLDO SISON CONVENTION CENTER TO THE FRONT OF PLAZA ENRIQUE BRAGANZA) INCLUDING THE INTERSECTION OF P. REINOSO STREET AND QUEZON AVENUE AND INTERSECTION OF BRAGANZA STREET AND QUEZON AVENUE; AND
2. G. MONTEMAYOR STREET (FROM THE INTERSECTION OF QUEZON AVENUE AND G. MONTEMAYOR STREET TO THE BUILDING EDGE OF DON LEOPOLDO SISON CONVENTION CENTER)

**EXPLANATORY NOTE**

**WHEREAS**, Article 43 of the Implementing Rules and Regulations of Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that, *"An LGU, may, through an ordinance, permanently or temporarily close or open any road, alley, park, or square within its jurisdiction;"*

**WHEREAS**, Article 45 (a) of the Implementing Rules and Regulations of the same Code further provides in part, that *"Any national or local road, alley, park, or square may be temporarily closed during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs, or undertaking of public works and highways, telecommunications, and waterworks projects xxx;*

**WHEREAS**, the Alaminos City Schools Division will be hosting the Regional Schools Press Conference (RSPC), the highest competition for journalism for both private and public elementary and secondary schools in the Philippines as per Republic Act 7079, also known as the Campus Journalism Act of 1991, from June 15-17, 2023;

**WHEREAS**, learner-participants from fourteen (14) schools division from the Ilocos Region will be coming to the city for the said event;

**WHEREAS**, since the RSPC is a big event for the Alaminos City Schools Division, they requested that the opening program be held at the Don Leopoldo Sison Convention Center (DLSCC);

**WHEREAS**, to ensure the safety of participants, there is a need to temporarily close portions of streets along the vicinity of the DLSCC;

**NOW, THEREFORE**, on motion of Councilor Verna S. D. Rabago, duly seconded by all members present

**BE IT ENACTED** by the Sangguniang Panlungsod in session duly assembled that:

**SECTION 1. TITLE.** — *An Ordinance Providing for the Temporary Full Closure of:*

- 1. Portion of Quezon Avenue (from the intersection of Braganza Street to the intersection of San Jose Drive—front of Don Leopoldo Sison Convention Center to the front of Plaza Enrique Braganza) including the intersection of P. Reinoso Street and Quezon Avenue and intersection of Braganza Street and Quezon Avenue; and*
- 2. G. Montemayor Street (from the intersection of Quezon Avenue and G. Montemayor Street to the Building Edge of Don Leopoldo Sison Convention Center)*

*on June 15, 2023 from 7:00 o'clock in the morning to 1:00 o'clock in the afternoon for the opening of the Regional Schools Press Conference in the City.*


**SECTION 2. GENERAL PROVISION.** — In line with the conduct of the Regional Schools Press Conference in the city, the following portions of streets are hereby temporarily closed on June 15, 2023 from seven o'clock in the morning to one o'clock in the afternoon (7:00 am to 1:00 pm) for the opening program/activity of the Regional Schools Press Conference:

1. Portion of Quezon Avenue (from the intersection of Braganza Street to the intersection of San Jose Drive-front of Don Leopoldo Sison Convention Center to the front of Plaza Enrique Braganza) including the intersection of P. Reinoso Street and Quezon Avenue and intersection of Braganza Street and Quezon Avenue; and
2. G. Montemayor Street (from the intersection of Quezon Avenue and G. Montemayor Street to the building edge of Don Leopoldo Sison Convention Center)


**SECTION 3. EFFECTIVITY CLAUSE.** — This ordinance shall take effect upon approval.




