**ORDINANCE NO. 2023-37**

**AN ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF PORTION OF C.P. GARCIA STREET (FROM THE INTERSECTION OF QUINTOS STREET AND C.P. GARCIA TO THE FRONT OF RABAGO BUILDING) AND PORTION OF QUINTOS STREET (FROM THE INTERSECTION OF SAN JOSE DRIVE AND QUINTOS STREET TO THE INTERSECTION OF C.P. GARCIA STREET AND QUINTOS STREET) FROM NOVEMBER 22, 2023 TO JANUARY 9, 2024 FOR THE ESTABLISHMENT OF CHRISTMAS BAZAAR 2023**

**EXPLANATORY NOTE**

**WHEREAS**, it has been a tradition in the City of Alaminos to establish Christmas Bazaar during the yuletide season for residents and tourists to enjoy while affording the local business sector additional opportunity and venue to market their products;

**WHEREAS**, Christmas Bazaar has been an additional attraction in the city during the yuletide season;

**WHEREAS**, the City Government of the city intends to continue the tradition of establishing Christmas Bazaar in the city, thus the need to temporarily close portions of some streets for the purpose;

**WHEREAS**, Article 43 of the Implementing Rules and Regulations of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991" provides that "An LGU may, through an ordinance, permanently or temporarily close or open any road, alley, park, or square within its jurisdiction";

**NOW, THEREFORE**, on motion of Councilor Verna S. D. Rabago, duly seconded by all members present

**BE IT ENACTED** by the Sangguniang Panlungsod in session duly assembled that:

**SECTION 1. GENERAL PROVISION.** — The following portions of streets are hereby temporarily closed for the establishment of Christmas Bazaar in the city, to wit:

Portion of C.P. Garcia Street (from the intersection of Quintos Street and C.P. Garcia to the front of Rabago Building) and portion of Quintos Street (from the intersection of San Jose Drive and Quintos Street to the intersection of C.P. Garcia Street and Quintos Street) from November 22, 2023 to January 9, 2024 for the establishment of Christmas Bazaar 2023.


**SECTION 2. EFFECTIVITY CLAUSE.** — This ordinance shall take effect upon approval.






