WHEREAS, it is hereby declared the policy of the State under Article 3 of the Local Government of Code 1991 that *the territorial and political subdivision of the State shall enjoy genuine and meaningful local autonomy to enable them to attain their fullest development.* Towards this end, the State shall provide for a more responsive and accountable local government structure instituted through a system of decentralization, whereby Local Government Units (LGU) shall be given more powers, authority, responsibilities and resources;

WHEREAS, Article 63, Rule XXII of the Local Government Code of 1991 provides that *every Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its priority needs, service requirements and financial capabilities consistent with the principles on simplicity, efficiency, economy, effectiveness, dynamism and public accountability, subject to the minimum standards and guidelines as prescribed by the Civil Service Commission;*

WHEREAS, to address the challenge of achieving a more responsive and cohesive human resource through the development of proactive, committed, and innovative employees that will help respond to the challenges and meet the public need for effective delivery of quality services, there is a need to transfer eleven (11) plantilla positions from different offices under the Executive Department of the Local Government Unit of the City of Alaminos, Pangasinan to other offices;

NOW, THEREFORE, upon due deliberation of the merits surrounding the issue and on motion of Councilor Dahlia M. de Leon, duly seconded by all members present

BE IT ENACTED, AS IT IS HEREBY ENACTED, BY THE SANGGUNIANG PANLUNGSOD IN SESSION DULY ASSEMBLED, THAT:

SECTION I. TITLE. — This ordinance shall be known as **“AN ORDINANCE TRANSFERRING ELEVEN (11) POSITIONS FROM ONE OFFICE TO THE OTHER UNDER THE EXECUTIVE DEPARTMENT OF THE LOCAL GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN.**

SECTION II. TRANSFER OF POSITIONS. — The following positions are hereby transferred:

1. Administrative Aide III (Utility II), SG 3/3 from the City General Services Office to the City Human Resource Management Office;
2. Administrative Aide III (Driver I), SG 3/3 from the City General Services Office to the City Human Resource Management Office;
3. Administrative Assistant I (AVEO III), SG 7/2 from the City General Services Office to the City Accounting Office;
4. Administrative Assistant I (AVEO III), SG 7/1 from the City Public Employment Service Office to the City Administrator’s Office;
5. Administrative Assistant III (Computer Operator II), SG 9/3 from the City Legal Office to the City Administrator’s Office;
6. Environmental Management Specialist II, SG 15/1 from the City General Services Office to the City Environment and Natural Resources Office;
7. Engineer III, SG 19/2 from the City General Services Office to the City Environment and Natural Resources Office;
8. Agricultural Technician II, SG 8/1 from the City Veterinary Office to the Office of the City Agriculture;
9. Agriculturist I, SG 11/3 from the City Agriculture Office to the Office of the City Agricultural and Biosystems Engineer;
10. Agriculturist I, SG 11/1 from the City Agriculture Office to the Office of the City Agricultural and Biosystems Engineer; and
11. Agricultural Technician II, SG 8/1 from the City Agriculture Office to the Office of the Agricultural and Biosystems Engineer Office.

SECTION III. FUNDING. — The funding requirements for transfer of the eleven (11) positions is reflected in the 2024 Annual Budget of the City of Alaminos, Pangasinan.

SECTION IV. EFFECTIVITY. — This ordinance shall take effect on January 01, 2024.




