ORDINANCE NO. 2024-11

ORDINANCE AMENDING PARAGRAPH II OF SECTION 5 OF CITY ORDINANCE NO. 2022- 13, ENTITLED AN "ORDINANCE PRESCRIBING FEES FOR MEDICINES, SUPPLIES AND SERVICES PROVIDED TO PATIENTS AT THE ALAMINOS CITY DIALYSIS CLINIC"

WHEREAS, Section 11 of Article XIII of the 1987 Philippine Constitution partly provides that *"the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all people at affordable cost. There shall be priority for the needs of underprivileged sick, elderly, disabled, women, and children. xxx"*

WHEREAS, the Alaminos City Hemodialysis/Renal Center also known as Alaminos City Dialysis Clinic was opened to accept dialysis patients on 24 August 2021;

WHEREAS, the amended fees for medicines, supplies and services provided to patients at the Alaminos City Dialysis Clinic were duly imposed pursuant to City Ordinance No. 2022-13 enacted on 04 October 2022;

WHEREAS, due to continuous increase in prices of medicines and other medical supplies, there is a need to amend Section 5 of Ordinance No. 2022-13 to ensure the viability of the operation of the Alaminos City Dialysis Clinic;

BE IT ENACTED, AS IT IS HEREBY ENACTED, BY THE SANGGUNIANG PANLUNGSOD IN SESSION DULY ASSEMBLED, THAT:

SECTION 1. TITLE. — This Ordinance shall be cited or known as An Ordinance amending Paragraph II of Section 5 of City Ordinance No. 2022- 13, entitled “An Ordinance Prescribing Fees for Medicines, Supplies and Services provided to patients at the Alaminos City Dialysis Clinic.”

SECTION 2. AMENDED SECTION. — Paragraph II of Section 5 of Ordinance No. 2022-13 which read as follows:

SECTION 5. The following are the prescribed fees at the Alaminos City Dialysis Clinic.
