ORDINANCE TEMPORARILY SUSPENDING THE IMPOSITION OF PENALTY ON WEARING OF SLIPPERS AND SHORTS BY TRICYCLE DRIVERS IN THE CITY DULY PROVIDED UNDER ARTICLE XXV (1) OF CITY ORDINANCE NO. 2021-13, OTHERWISE KNOWN AS "THE 2021 AMENDMENT TO THE TRAFFIC CODE" OF THE CITY OF ALAMINOS, PANGASINAN, FROM 28 JUNE 2024 TO 04 NOVEMBER 2024

WHEREAS, pursuant to Rule XVI, Article 99 (3) (vi), the Sangguniang Panlungsod of this city duly enacted City Ordinance No. 2002-27, otherwise known as the "City of Alaminos Tricycle Ordinance";

Third Offense - A fine of PhP 3,000.00 and cancellation of local franchise issued by the City Government of Alaminos upon due notice;






