**AN ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF PORTION OF TAY-AC ROAD (FROM BRGY. QUIBUAR BRIDGE TO BRGY. LINMANSANGAN) ON AUGUST 9, 2024, FROM 5:30 IN THE MORNING (5:30 AM) TO TWELVE O'CLOCK NOON (12:00 NOON) TO SERVE AS VENUE FOR THE LAUNCHING AND RIBBON-CUTTING OF THE ILOCOS REGION RICE TECHNOLOGY DEMONSTRATION AND FIELD WALK ALONG THE SHOWCASE AREAS INCLUDING BIOFERTILIZER TECHNO DEMO**

**EXPLANATORY NOTE**

**WHEREAS**, Article 43 of the Implementing Rules and Regulations of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that "An LGU, may, through an ordinance, permanently or temporarily close or open any road, alley, park, or square within its jurisdiction;"

**WHEREAS**, Article 45 (a) of the Implementing Rules and Regulations of the same Code further provides in part, that "Any national or local road, alley, park, or square may be temporarily closed during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs, or undertaking of public works and highways, telecommunications, and waterworks projects xxx;

**WHEREAS**, the Local Government of the City of Alaminos, Pangasinan has been continuously strengthening its support to the agricultural sector in the city through collaborations with national and other local agencies in the provision of interventions to further increase rice and vegetable production;

**WHEREAS**, one of the identified activities to provide such support to farmers is the launching and ribbon-cutting of the Ilocos Region Rice Technology Demonstration and Field Walk along the showcase areas including biofertilizer techno demo slated on 9 August 2024 at Brgy. Quibuar and Brgy. Linmansangan, this city;

**WHEREAS**, farmers and other guests coming from different municipalities in the province will be attending the said event, thus, necessitating the need to temporarily close the above named road to serve as venue of the event;

**NOW, THEREFORE**, on motion of Councilor Verna S. D. Rabago, duly seconded by all members of the Sangguniang Panlungsod present

**BE IT ENACTED, AS IT IS HEREBY ENACTED, BY THE SANGGUNIANG PANLUNGSOD** in a session duly assembled, that:

**SECTION 1. TITLE.** — *An ordinance providing for the temporary full closure of portion of Tay-ac Road (from Brgy. Quibuar Bridge to Brgy. Linmansangan) on August 9, 2024, from 5:30 in the morning (5:30 am) to twelve o'clock noon (12:00 noon) to serve as venue for the launching and ribbon-cutting of the Ilocos Region Rice Technology Demonstration and Field Walk along the showcase areas including biofertilizer techno demo.*

**SECTION 2. GENERAL PROVISION.** — In line with the conduct of the launching and ribbon-cutting of the Ilocos Region Rice Technology Demonstration and Field Walk along the showcase areas including biofertilizer techno demo, portion of Tay-ac Road (from Brgy. Quibuar Bridge to Brgy. Linmansangan) is hereby temporarily closed on August 9, 2024, from 5:30 in the morning (5:30 am) to twelve o'clock noon (12:00 noon) to serve as venue for the said activities;

**SECTION 3. EFFECTIVITY CLAUSE.** — This ordinance shall take effect upon approval.
