AN ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF A PORTION OF C.P. GARCIA STREET (FROM THE INTERSECTION OF QUEZON AVENUE AND C.P. GARCIA STREET TO THE FRONT OF RABAGO BUILDING) AND A PORTION OF QUINTOS STREET (FROM THE INTERSECTION OF SAN JOSE DRIVE AND QUINTOS STREET TO THE INTERSECTION OF C.P. GARCIA STREET AND QUINTOS STREET) FROM NOVEMBER 27, 2024 (5:00 PM) TO JANUARY 13, 2025 (12MIDNIGHT) FOR THE ESTABLISHMENT OF CHRISTMAS BAZAAR 2024

WHEREAS, the Local Government Unit of Alaminos City intends to continue the tradition of establishing a Christmas Bazaar in the city, thus the need to temporarily close portions of some streets for the purpose;

WHEREAS, Article 43 of the Implementing Rules and Regulations of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that "An LGU may, through an ordinance, permanently or temporarily close or open any road, alley, park, or square within its jurisdiction";

NOW, THEREFORE, on motion of Councilor Verna S. D. Rabago, duly seconded by all members present

BE IT ENACTED by the Sangguniang Panlungsod in session duly assembled that:

SECTION 1. GENERAL PROVISION. — The following portions of streets are hereby temporarily closed for the establishment of the Christmas Bazaar in the city, to wit:

A Portion of C.P. Garcia Street (from the intersection of Quezon Avenue and C.P. Garcia Street to the front of Rabago Building) and a portion of Quintos Street (from the intersection of San Jose Drive and Quintos Street to the intersection of C.P. Garcia Street and Quintos Street) from November 27, 2024 (5:00 PM) to January 13, 2025 (12Midnight) for the establishment of Christmas Bazaar 2024.

SECTION 2. EFFECTIVITY CLAUSE. — This ordinance shall take effect upon approval.
