AN ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF PORTION OF ROAD (FROM BRGY. QUIBUAR BRIDGE GOING TO BRGY. LINMANSANGAN WELCOME ARC) ON JANUARY 31, 2025, FROM FIVE O'CLOCK IN THE MORNING (5:00 AM) TO TWO O'CLOCK IN THE AFTERNOON (2:00 PM) TO SERVE AS VENUE OF THE FARMERS' FIELD DAY AND PROVINCIAL RICE TECHNOLOGY FORUM



EXPLANATORY NOTE

WHEREAS, Article 43 of the Implementing Rules and Regulations of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that "An LGU, may, through an ordinance, permanently or temporarily close or open any road, alley, park, or square within its jurisdiction;"

WHEREAS, Article 45 (a) of the Implementing Rules and Regulations of the same Code further provides in part, that "Any national or local road, alley, park, or square may be temporarily closed during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs, or undertaking of public works and highways, telecommunications, and waterworks projects xxx;

WHEREAS, the Local Government of the City of Alaminos, Pangasinan has been continuously strengthening its support to the agricultural sector in the city through collaborations with national and other local agencies in the provision of interventions to further increase rice and vegetable production;

WHEREAS, one of the identified activities to provide such opportunity to farmers is Farmers' Field Day and the Provincial Rice Forum which is slated on 31 January 2025 at Brgys. Linmansangan and Quibuar, this city;

WHEREAS, farmers and other guests coming from different municipalities in the province will be attending the said event, thus, necessitates the need to temporarily close the above named portion of road to serve as venue of the event;

NOW, THEREFORE, on motion of Councilor Verna S. D. Rabago, duly seconded by all members present

BE IT ENACTED, AS IT IS HEREBY **ENACTED**, BY THE SANGGUNIANG PANLUNGSOD IN SESSION DULY ASSEMBLED, THAT:

SECTION 1. TITLE. — *An ordinance providing for the temporary full closure of portion of road (from Brgy. Quibuar Bridge going to Brgy. Linmansangan Welcome Arc) on January 31, 2025, from five o'clock in the morning (5:00 AM) to two o'clock in the afternoon (2:00 PM) to serve as venue of the Farmers' Field Day and Provincial Rice Technology Forum.*

SECTION 2. GENERAL PROVISION. — In line with the conduct of Farmers' Field Day and Provincial Rice Forum, the following portion of road (from Brgy. Quibuar Bridge going to Brgy. Linmansangan Welcome Arc) is hereby temporarily closed on January 31, 2025, from five o'clock in the morning (5:00 AM) to two o'clock in the afternoon (2:00 PM) to serve as venue of the Farmers' Field Day and Provincial Rice Technology Forum.

SECTION 3. EFFECTIVITY CLAUSE. — This ordinance shall take effect upon approval.


