ORDINANCE NO. 2025-07

AN ORDINANCE AMENDING PARAGRAPH I, SECTION 5 OF ORDINANCE NO. 2022-13 ENTITLED "ORDINANCE PRESCRIBING FEES FOR MEDICINES, SUPPLIES AND SERVICES PROVIDED TO PATIENTS AT THE ALAMINOS CITY DIALYSIS CLINIC, AMENDING FOR THIS PURPOSE SECTION 5 OF ORDINANCE NO. 2021-02 AND REPEALING ORDINANCE NO. 2022-07 ENACTED ON 27 JUNE 2022 OF THE CITY OF ALAMINOS, PANGASINAN" TO PRESCRIBE THE ADJUSTED RATE FOR HEMODIALYSIS TREATMENT BENEFIT PACKAGE PURSUANT TO PHILHEALTH CIRCULAR NO. 2024-0023

WHEREAS, pursuant to PhilHealth Circular No. 2024-0023, the Philippine Health Insurance Corporation (PhilHealth) adjusted the Hemodialysis benefit package from PhP 4,000.00 to PhP 6,350.00;

WHEREAS, the Local Government Unit of the City of Alaminos, Pangasinan owns and operate the Alaminos City Hemodialysis/Renal Center catering to dialysis patients in the locality;

WHEREAS, Paragraph I of Ordinance No. 2022-13 provides for the rate of dialysis treatment service fee as follows:

- New: PhP 3,250.00 (inclusive of dialyzer, bloodlines and doctor's fee)*
- Re-use: PhP 2,600.00 (inclusive of dialyzer, bloodlines and doctor's fee)*
- PCSO: PhP 2,600.00 charge to PCSO*

WHEREAS, to fully avail of the adjusted rate for hemodialysis benefit package from the PhilHealth, there is a need to amend the above stated provision under paragraph I Section 5 of Ordinance No. 2022-13 enacted on 04 October 2022;

NOW, THEREFORE, on motion of Councilor Froebel A. Ranoy, duly seconded by all members present

BE IT ENACTED, AS IT IS HEREBY ENACTED, BY THE SANGGUNIANG PANLUNGSOD IN SESSION DULY ASSEMBLED, THAT:

SECTION 1. Paragraph I Section 5 (I) of Ordinance No. 2022-13 entitled *“Ordinance Prescribing Fees for Medicines, Supplies and Services Provided to Patients at the Alaminos City Dialysis Clinic, Amending for this Purpose Section 5 of Ordinance No. 2021-02 and Repealing Ordinance No. 2022-07 Enacted on 27 June 2022 of the City of Alaminos, Pangasinan”* which provides:

SECTION 5. The following are the prescribed fees at the Alaminos City Dialysis Clinic.

I. RATE OF DIALYSIS TREATMENT SERVICE FEE:

- New : PhP 3,250.00 (inclusive of dialyzer, bloodlines and doctor's fee)
- Re-use : PhP 2,600.00 (inclusive of dialyzer, bloodlines and doctor's fee)
- PCSO : PhP 2,600.00 charge to PCSO

Is hereby amended to read as follows:

I. RATE OF DIALYSIS TREATMENT SERVICE FEE:

- New : PhP 6,350.00 (inclusive of dialyzer, bloodlines and doctor's fee)
- Re-use : PhP 2,600.00 (inclusive of dialyzer, bloodlines and doctor's fee)
- PCSO : PhP 2,600.00 charge to PCSO

SECTION 2. This ordinance shall take effect upon compliance with statutory requirements in the enactment of an ordinance.




